ADVERTISEMENT

Online applications are invited from citizen of India for filling up 1(one) post of Assistant System Manager Group- B (Non Gazetted), under the Office of The Chief Electoral Officer, Arunachal Pradesh, Itanagar in Level 6 Rs.35,400 - 1,12,400 under Pay Matrix of 7th Central Pay Commission plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The lone post is kept Unreserved for open competition. The vacancy position is subject to variation.

(1) EDUCATIONAL QUALIFICATION :

Candidate applying for the post must possess B.E/B.Tech in Computer Science/Computer Application/Information Technology/Electronic & Communications Or M.sc. in Electronic/Electronics & Communications/Electronic & Instrumentation/Computer Science/Information Technology/Computer Applications Or MCA from a recognized University or Institution.

(2) AGE LIMIT:

The candidates must have attained 21 years of age and should not be more than 32 years as on **13.03.2020**. However, the upper age limit is relaxable to 5 years for APST candidates and another 5 years relaxation to APST candidates of A P state govt. employees.

(3) METHOD OF SELECTION :-

The eligible candidate will have to appear in the written examination in the following subjects:-

A candidate who has secured a minimum of 33 % or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-Voce. In other words selection for viva-voce test shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva-voce.

N.B The Commission will conduct recruitment test (Objective Type) before written examination, if it is deemed necessary to do so.

(4) HOW TO APPLY :-

Candidates are required to apply online only through the official website www.appsonline.in. Brief instructions for filling up online application are available on the above mentioned website.

(5) Scanned copies of following documents and information are to be attached/uploaded.

- (i) Scanned signature of the candidate on white paper with black ink pen (20-60 kb in jpg format).
- (ii) Latest/Recent passport size photo(40-100 kb in jpg format).

(6) The candidates who have been declared qualified in written examination will have to submit Xerox copies of the following documents/information to the Commission before one week from the actual date of interview.

- (i) Recent passport size photograph
- (ii) Matriculation certificate issued by Board/University for proof of date of birth.
- (iii) Class XII Certificate with Marksheet.
- (iv) Degree certificate with Mark sheet issued by the Assistant Registrar/Registrar/Controller of Examination/Vice Chancellor of the concerned University to ascertain educational qualification.
- (v) Master Degree Certificate with Marksheet
- (vi) APST Certificate.
- (vii) Any other documents as may be relevant.
- (viii) Intimation letter to HoD/NOC for those who are in regular Govt. Service.


