**SUB: Exam city preferences and conduct of computer based test for the post of Forest Guard, Forest Ranger and Wildlife Guard/ Game Watcher.**

In continuation of the Direct Recruitment Notice No. F.No.1(39)/DCF(HQ)/Estt./Rect-EdCIL/2019/Pt.file/10946 dated 27/12/2019 published in the Employment News in 18 Jan – 24 Jan 2020 edition ( also available on the website of the Department); due to large number of applications, it is decided that the online examination will now be held at centers spread across the country instead of Delhi/NCR alone.

**Conduct of exam on All India Level**

***Due to large number of applications, computer based exam for Forest guard, Forest Ranger and Wildlife Guard would be now conducted on All India level instead of Delhi/NCR alone.***

**I. Regarding posts for Wildlife Guard and Forest Ranger**

**1. City Preference for posts of Wildlife Guard and Forest Ranger**

An online link will be made live from 20<sup>th</sup> February 2020 till 24<sup>rd</sup> February 2020 for the posts of Wildlife Guard and Forest Ranger. Candidates who have submitted the application will have to re-login on link available on Department of Forests and Wildlife website and select their exam city preference.

**Note: If any candidate fails to submit city preference latest by 24.02.2020 for the posts for Forest Ranger and Wildlife Guard/Game Watcher, then center for online test would be allocated near the city of present address mentioned by the candidate in the application form or Delhi/NCR wherever feasible, depending upon availability.** However, Department of Forests & Wildlife reserves the right to cancel or add more cities and centres. The computer based test city/center could be shifted to any other city/center of examination depending upon the administrative feasibility.

No claim will be accepted from candidate on account of exam city preference after 24<sup>rd</sup> February 2020 for the posts of Wildlife Guard and Forest Ranger.
