Attention is invited to the Notice No.: DMRC/HR/Rectt./I/2019/RNE15(A)/2020, dated: 21/04/2020, vide which provisional result for the post of Stenographer, to appear in document verification and Skill Test, for 09 nos. of vacancies, was notified.

In the light of the outbreak of COVID-19, DMRC services were not running from 22/03/2020 – 06/09/2020, i.e., 169 days. There was also an overall reduction in the activities of DMRC. Consequently, and due to administrative reasons, the man-power requirements were reviewed, leading to reduction in the requirements, across various Departments.

**It was, therefore, decided to reduce the number of vacancies for the post of Stenographer (RNE15) from 09 to 07, as detailed below: -**

conditions of eligibility or if any information is found to be incorrect or false, at any point in time, his/her candidature will be cancelled.

2. The fact that a candidate has been shortlisted provisionally for the Skill Test does not confer any right on him/her to be treated as eligible in all aspects for appointment.
3. The candidates shall report at the nominated venue. No request for change in date, time, venue of the Skill Test would be entertained.
4. Candidates are advised to bring the following documents, in original and self-attested copy, to be produced & submitted at the time of documents verification, failing which they will not be allowed to appear in the Skill Test: -
  - Colour copy of the online application form;
  - Colour copy of the Admit Card for Skill Test;
  - Minimum 05 recent colour passport photographs. The photographs must resemble the photograph that they had uploaded in their online application form;
  - Proof of Date of Birth (as per SSC/Matriculation Certificate);
  - Educational Qualification Certificates/Degree and Year/Semester-wise Marksheets (Matriculation onwards);
  - CGPA/CPI to percentage conversion formula, if applicable, as adopted by the University/Institute;
  - SC/ST/OBC/EWS certificates issued by the Competent Authority, if belonging to reserved community and requiring reservation/concession/relaxation, which was uploaded at the time of filling online application form.
