NOTIFICATION

In 2017, Government of Kerala enacted the Kerala Maritime Board Act 2017 and constituted the Kerala Maritime Board (KMB) by merging the establishments of Directorate of Ports, Kerala State Maritime Development Corporation Limited and Kerala Maritime Society. On behalf of the Kerala Maritime Board, the nodal agency for all maritime-related activities in Kerala, the Centre for Management Development (CMD) invites applications from Qualified and Competent Candidates for appointment to various posts on Contract Basis. Interested candidates may apply via ONLINE mode only by filling the prescribed application form given in the website of Centre for Management Development (CMD), Thiruvananthapuram (https://kcmd.in/). The online application submission link will open on 08.02.2023 (10:00 AM). The last date for submitting online application is 22.02.2023 (5:00 PM).

The details regarding the qualification and experience required, number of vacancies, upper age limit, remuneration and mode of appointment are given below:

Note: Candidates will have to upload their updated Curriculum Vitae (CV), passport size photograph (taken within six months), signature and copies of certificates proving qualification and experience while submitting the application. The photograph and signature must be in JPEG format. The size of the photograph must be less than 200 kB and the size of the signature should be less than 50 kB. The CV and the copies of certificates shall be either in JPEG format or in PDF format, and shall not exceed 3MB in size.

Instructions to Candidates

- Period of Contract to all Posts will be initially one year and are renewable based on Government Decision and Performance of the Candidates.
- Category I posts will be appointed directly by the Kerala Maritime Board.
- Category II posts will be appointed at the Office(s) of Kerala Maritime Board through the Centre for Management Development.

• Cut-off date for calculating Age and Experience is on 01.02.2023

- It shall be noted that admittance to various stages of the recruitment will be provisional only, and will not confer any claim unless various other conditions of selection processes are satisfied. Detailed scrutiny of the applications/credentials will be conducted before interview/appointment. Any discrepancy found during the detailed scrutiny will result in the rejection of candidature.
- Norms of selection will be as per those applicable for contract posts in the Government of Kerala.
- The recruited individuals will be supported to build their capacities in carrying out their functions.
- Age relaxation is applicable to SC/ST/OBC/PWD and other eligible category applicants as per Govt. of Kerala norms. Eligibility for age relaxation should be proven by producing necessary certificates from competent authority.
- Only shortlisted candidates will be intimated by email/SMS regarding further procedures. Hence, candidates must ensure that working email address and telephone/contact no. are being provided.
- The medium for all written tests will be English.
- KMB/CMD reserves the right to shortlist only a limited number of candidates for written test/technical presentation/technical interview/final interview, as the case may be for the post, based on marks secured in their qualifying examination and/or years of relevant experience. Candidates should clearly mention the marks scored in their qualifying examination in the application. The onus of proving the conversion from grade/CGPA to percentage of marks would rest with the candidate.
- Equivalency certificate of the respective University shall be produced for considering any other degree with reference to the notified degrees.
- Any type of canvassing for favouritism will be considered offensive and legal action will be taken against those who attempt to do so.
- In the event of any information provided by the candidate being found false or incorrect at any stage, their candidature/appointment is liable to be cancelled/terminated without any notice.
