The mark secured by the last candidate in the Main List is **56 (fifty six)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section Category, if any, necessary supplementary list is prepared by including sufficient numbers of candidates from lowermark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should be present in person and produce the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated through profile message and SMS.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Probability List are required to produce Community Certificate (in Form III / Digitally Signed) issued by the competent Revenue Authority, Candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No 81/2009/SCSTDD dated 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS Certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **12-08-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
