Note :- (6) Candidates belonging to other backward classes included in the Short List are required to produce Non Creamy Layer Certificate, as per G.O(P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018, and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on 09.11.2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Invalidation Notification No :ERVII (3)1/2024/KPSC dated 23.02.2024.
