## **Nature of Work of Consultant and Technical Assistant:**

The Consultant and Technical Assistant will be attached to an officer and will have to perform under Officer's supervision, and the nature of work may include few or all of the following:

- 1. Identify the establishments/industries located in different States of Northern Region from various sources viz. different Chamber of Commerce, CII, FICCI, Industry Associations, internet and any other sources.
- 2. Follow up with establishments, institutions, students, and apprentices w.r.t. implementation of Apprentices Act, 1961 as amended from time to time for Engineering/Technology Degree and Diploma passouts, and Graduates in general streams.
- 3. Visit to establishments on need basis and make necessary assessment, filling-up of the forms, presentation of documents etc. so as to pursue the industries/establishments to voluntarily come forward and engage apprentices.
- 4. Placement/engagement of apprentices in notified establishments by coordinating with the institutions/agencies.
- 5. Perform such other functions as may be assigned by the Officers of the Board from time to time.

### **Remuneration:**

#### For Technical Assistant

Pay 35000/- per month for Graduates in general streams & Rs.40,000/- per month for Graduates in Engineering/Technology

### **For Consultant**

A monthly amount arrived at by deducting the basic pension from the pay drawn at the time of retirement.

### **Important instructions to the applicants:**

- 1) The appointment against these posts will be purely on Contractual basis.
- 2) Selection of Consultant and Technical Assistant may be done in phased manner as per requirement of manpower.
- During the course of contract, Technical Assistant and Consultant will be required to keep all information; documents and other material obtained in the course of duty strictly confidential and shall return all such information and materials that may be in his/her possession to BOAT(NR) on separation.
- 4) Unsatisfactory performance, misconduct or remaining on unauthorized absence from duty will result in removal/termination of contractual service forthwith.
- 5) The contract shall be terminated by either party giving 30 days' notice in writing or salary in lieu of notice, to the other.
- The candidates are required to serve in any states (Northern Region) within the jurisdiction of BOAT(NR) but effort shall be made to accommodate the selected candidates in their home state/neighboring state or nearest BOAT(NR) office.
- BOAT(NR) reserves its right to place a reasonable limit on the total number of candidates to be called. Candidates having higher qualification/marks/relevant experience may be given preference in shortlisting if required to restrict the number of candidates to be called for interview etc.
