**Note 2:** The maximum age-limit for appointment on deputation (including short term contract) shall be not exceeding fifty-six years as on the last date of receipt of applications.

5.Regulation of Terms and Conditions for deputation: The Terms and Conditions for deputation of the officials selected shall be regulated as per DoT OM No.20-01/2023-SEA-II dated 31.10.2023, its corrigendum dated 01.11.2023, DOPT OM No. DOPT-1716267027220 dated 28.03.2024, its corrigendum issued time to time.

- 6. **Age limit:** The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.
- 7. **Selection procedure:** Eligible and willing candidates may apply through proper channel in the prescribed format. Heads of Departments are requested to forward applications of eligible and willing candidates along with attested **copies of 5 years APAR**, declaration, certification as mentioned in the application form, whose services can be spared on deputation, immediately on their selection.
- 8. The applications of suitable and eligible officers complete in all respects in the prescribed format (Annexure) along with requisite documents may be forwarded to ADG (Admin & HR), O/o Special DGT Delhi LSA- 5th Floor Mahanagar Doorsanchar Bhawan, Near Zakir Hussain College, Jawaharlal Nehru Marg (Old Minto Road) New Delhi-110002.

However, such applications will be considered only on receipt of the duly signed physical copy of the same in this office.
