Note:

1. For the above mentioned vacancies, reservation for SC/ST/OBC/PWD/EWS categories will be applicable as per provisions of Ministry of Skill Development and Entrepreneurship, Central Apprenticeship Rules, Apprentices Act 1961, Apprenticeship Rules, 1992 and Apprenticeship (Amendment) Rules, 2015 & 2019.
2. The number of vacancies mentioned above is only indicative and may change at a later stage depending on the final assessment of eligible application received.

Part- 1 Important instructions:

1. The engagement and training will be strictly in accordance with Apprentices Act, 1961, Apprenticeship Rules and its amendments from time to time and **there is no obligation for employment of apprentices on completion of their training.**
2. The tenure of the apprenticeship for the above categories / trades would be **12 months** commencing from execution of the contract of Apprenticeship
3. Registration of (i) Diploma (Engineering) candidates on (<http://nats.education.gov.in>) and (ii) ITI candidates on portal (www.apprenticeshipindia.org or www.apprenticeshipindia.gov.in) is mandatory. Kindly see respective websites for registration. The registration No. is required to be mentioned while filling the application form.
4. The above registration No. is liable to be verified at the time of selection / Document verification.
5. **For Diploma (Engineering – Apprentice Trainees)** Candidates who have passed in the year **2023/2024/2025 (last three years)** as regular candidates are only eligible to apply. Candidates who passed the qualifying exam earlier than the year **2023** are not eligible.
6. **ITI apprentice** : Candidates must have completed ITI from NCVT or SCVT Boards. Candidates who have passed in the year **2023/2024/2025 (last three years)** as regular candidates are only eligible to apply. Candidates who passed the qualifying exam earlier than the year **2023** are not eligible.
7. OBC certificate whose validity has expired would not be accepted for granting concession
8. **Candidates with higher qualification are not eligible to apply.**
9. Application of those candidates who have appeared in the qualifying examination, but whose results have not been declared /available as on the date of advertisement will **NOT** be considered for training. Provisional Degree Certificates of qualifying exam would however be acceptable during the time of joining, but final degree certificates shall have to be submitted as & when received for verification and acceptance.
10. Suppressions of facts will lead to disqualification, at any stage of the selection process or during the training period.
11. Selection of candidates from SC/ST/OBC/PWD/EWS category would be as per Apprenticeship Rules.
12. PWD candidates are eligible only for the designated trades as per Apprenticeship Rules.

13. **Candidates who have already undergone Apprenticeship Training or at present undergoing Apprenticeship Training under any organization are NOT eligible to apply.**
14. **Candidates with more than one year work experience are NOT eligible to apply,**
15. **No TA/DA shall be given to the candidates for interviews / Document verification / joining DIBT as Apprentice Trainees.**
16. **The Apprentice Trainee will not be provided any quarters / hostel accommodation by this establishment at the time of interview and also during the training period.**

Part-2 Stipend:

Candidates finally selected for the Apprenticeship Training would be eligible for stipend as given below as per Govt. of India rules:

(i) **Engineering Stream:**

- . Diploma Apprentice : Rs. 8000/- per month
- . ITI Apprentice : Rs. 7000/- per month

Part -3 Medical Fitness:

The candidate should possess satisfactory health. Candidates finally selected will have to produce Fitness Certificate issued by authorized medical officer of any Government Hospital as per DIBT specified format during joining time. Certificate issued by ESIC Hospitals will **NOT** be accepted. Final selection of the candidate depends upon his/her fulfilling health standards as prescribed in Apprentices Act, 1961 and Apprenticeship Rules 1992 as amended from time to time.

Part -4 Selection Process :

1. **Diploma Apprentice Trainees /ITI Apprentice Trainees :** Depending upon the vacancies available in various disciplines, selection of candidates will be carried out by shortlisting on the basis of Academic Merit subjects to satisfactory verification of the documents.

Part -5 How to Apply:

1. Applications are invited through website <https://nats.education.gov.in> (only for Diploma) and www.apprenticeshipindia.org (only for ITI Trades). 2. The last date for the applications is one month from the date of publication of advertisement.
3. Candidates are requested to fill up correct details against all the fields along with uploading of scanned copies of all the mandatory documents (as per list).
4. Candidates are required to bring a **copy of application printout** along with the originals documents at the time of joining at DIBT, Mysore.

Part -6 General Instructions:

1. It should be noted that the selection and training of apprentices are strictly in compliance with the provisions of Apprentices Act 1961 and its amendments. **NO EMPLOYMENT IS GUARANTEED TO THE APPRENTICES ON COMPLETION OF THEIR TRAINING.**
2. Candidates before filling the application form shall ensure that they fulfill all the eligibility conditions for the apprenticeship training. If, at any stage of selection or even after selection and joining or during training, it comes to notice that the candidate / trainee does not fulfill any of the eligibility conditions or the facts stated are not true or the documents enclosed by the applicant are false/ forged, the candidature of joining such individual shall be withdrawn immediately without assigning any reason.
3. All applicants are required to bring original certificates along with the printout of the application from along with one set of photocopies (self-attested) of the following documents during **document verification /joining**:-

 - (iii) Caste Certificate (if applicable)

 - (vi) EWS certificate (if applicable)
 - (vii) Two Passport size photographs
 - (viii) Police Verification Certificate (District Authority)
 - (ix) Medical Fitness Certificate
4. The DIBT reserves the right to amend / refix / cancel / suspend the selection process at any time during the process without assigning any reason whatsoever. The decision of the DIBT shall be final and binding and no appeal of any kind shall be accepted / entertained /considered in this regard.
