A: CATEGORY-1 ENGINEERING GRADUATE APPRENTICES:

Must satisfy one of the educational qualifications given below:

- (a) degree in engineering or technology granted by a statutory University.
- (b) degree in engineering technology granted by an institution empowered to grant such degrees by an Act of parliament.
- (c) Graduate examination of professional bodies recognized by the Central Government as equivalent to a degree.

B: CATEGORY-2 ENGINEERING TECHNICIAN (DIPLOMA) APPRENTICES:

Must satisfy one of the educational qualifications given below:

- (a) A diploma in engineering or technology granted by a State Council or Board of Technical Educational established by a State Government.
- (b) A diploma in engineering or technology granted by University.
- (c) A diploma in engineering or technology granted by an institute recognized by the State Government or Central Government as equivalent to (a) and (b) above.

- II AGE: 18-27 years as on 01.04.2025 .Relaxation to reserved category as per guidelines in this regard.
- III **RESERVATION OF VACANCIES**: Guidelines on reservation for SC/ST/OBC under Apprentices Act and Mormugao Port Authority will be followed. Those candidates who are claiming reservation under SC/ST/OBC shall provide a certificate in this regard, failing which their claim for reservation will be considered as "General" category only.
- IV. **DURATION OF TRAINING**: The duration of Apprenticeship training will be for a period of one year as per Apprentices (Amendment) Act, 1973.
- V. SELECTION PROCEDURE: The final rank list would be prepared according to categories General/SC/ST/OBC on the basis of marks obtained by the candidates, The Selection will be made from the candidates who fulfill the minimum standard educational qualification and medical fitness.

Conditions of Engagement of Engineering Graduate & Technician and Trade Apprentices for the Year 2025–2026

- Guidelines on reservation for SC/ST/OBC under Apprentices Act and Mormugao Port Authority (MPA) will be followed. Those candidates who are claiming reservation under SC/ST/OBC shall provide a certificate in this regard, failing which their claim for reservation will be considered as 'General' category only.
- 2. The selection will be made from the candidates who fulfil the minimum standard educational qualification and medical fitness.
- 3. The final list would be prepared according to categories General / SC / ST / OBC on the basis of marks obtained by the candidates.
- 4. The selection will be made from the candidates who fulfil the minimum standard educational qualification and medical fitness.
- 5. MPA will not be responsible for the regular appointment after completion of training.
- 6. The interview call letters to eligible candidates will be sent by post on registered address. MPA shall not be responsible if call letters are not delivered in time by post.
- 7. No TA / DA will be paid for attending certificate verification or during apprenticeship training.
- 8. No boarding or lodging expenses are admissible.
- 9. Stipend will be paid in accordance with the Gazette of India, Notification dated 25th September, 2019, G.S.R.686 (E), for the minimum rate of stipend per month payable to apprentices per month as per the qualifications stipulated in the curriculum.
- 10. Graduate/Technician apprentices must get himself/herself enrolled/registered through on-line enrolment at www.nats.education.gov.in and poses a valid enrolment ID generated after successful enrolment within a specified period of three years after passing qualifying examination.
- 11. No Engineering Graduate or Diploma Holder who had training or job experience for a period one year or more, after the attainment of these qualifications shall be eligible for being engaged as an apprentice under the Act.
- 12. No Sandwich Course Student shall be eligible for being engaged as an apprentice under the Act after passing the final examination of the technical institution wherein such student is undergoing the course unless so approved by the Regional Central Apprenticeship Advisers.
- 13. A person who has been a Graduate or Technician apprentice under the Act and in whose case the contract of apprenticeship was terminated for any reason whatsoever shall not be eligible for being engaged as an apprentice again under the Act without the prior approval of the Apprenticeship Adviser.
- 14. MPA may in the first instant make selection from the list of candidates by preparing list directly from the student data base from the National Web portal https://nats.education.gov.in
- 15. The eligible candidates may visit https://nats.education.gov.in to apply in case of Engineering/Diploma apprentices (graduate or technician) and https://apprenticeshipinda.org in case of Trade apprentices. Apprentices must be registered/ enrolled on the respective Apprenticeship portals on or before 29.08.2025.

- 16. The candidature of applicant would be provisional and subject to subsequent verification of certificates and testimonials. In case, it is detected at any stage of engagement or thereafter, that a candidate does not fulfill the eligibility norms and or/ that he/she has furnished any incorrect / false information / certificate / documents or has suppressed any material fact, his / her candidature will stand cancelled.
- 17. Apprentice must have an Aadhaar number / or a Unique Identification Number in the case of J & K and North-East candidates/apprentices.
- 18. Any online application of trade and engineering apprentices received after the due date of 29.08.2025 will not be considered.
