The prescribed fee for raising objection is Rs. 500/- plus applicable Bank Service Charges for each question. Fee once paid shall not be refunded under any circumstances.

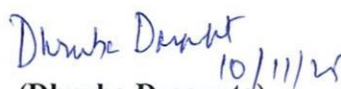
MODE OF PAYMENT OF FEE:
