Reservations for SC/ST/OBC/EWS/PwD candidates will be followed as per Govt. norms. If sufficient Engineering Graduates are NOT attending / joining the apprenticeship, the vacant positions will be engaged with Diploma holders and vice versa.

## **2. AGE LIMIT**

Maximum age of 25 years or less as on **31-12-2025**. Upper age limit is relaxed by 5 years for SC/ST, 3 years for OBC (NCL) & 10 years for PwD (40% and above disability) candidates.

## **3. APPRENTICESHIP PERIOD**

The tenure of the Apprenticeship would be **One Year** only, which will commence from **09-02-2026**.

## **4. ESSENTIAL QUALIFICATION & ELIGIBILITY CRITERIA**

- a. Candidates who have passed B.E./ B.Tech. course in the above-mentioned engineering branches on or after **1<sup>st</sup> April 2023**, from AICTE approved colleges / recognized Indian Universities for GEA.
- b. In case of Diploma Apprentices, the candidates who have passed 3 Years Diploma course in above mentioned branches on or after **1<sup>st</sup> April 2023**.
- c. Candidates residing All Over India and only Indian residents are eligible to apply.

## **5. HOW TO APPLY**

**STEP 1:** Interested candidates who possess the required criteria/educational qualification **MUST** register themselves on the website of the **National Apprenticeship Training Scheme (NATS)** i.e. **[www.nats.education.gov.in](http://www.nats.education.gov.in)**.

**STEP 2:** Subsequent to registration in the portal mentioned above, the interested eligible candidates shall submit the online application through **ECIL website: [www.ecil.co.in](http://www.ecil.co.in)>Careers>Current Job Openings**.

**IMPORTANT NOTE:** Applications submitted on the ECIL website shall only be accepted and considered.

- a. After applying online, the candidate is required to take the printout of the registered online application form with system-generated application serial number. Candidate is required to note down application serial number, for all future references. The candidate can take a re-print of his/her registered online application form before the last date for Online registration.
- b. The candidate has **to quote his/her system-generated online application number** for all future correspondence.

- c. No separate communication will be sent to any candidate on their non-selection at any stage of the engagement process.
- d. The application is liable for rejection at any stage of the recruitment process in case it is submitted with incorrect information. Further, if any other shortcoming is noticed (either at the instance of a candidate or otherwise) even after Apprenticeship commencement, his/her apprenticeship will be liable for termination forthwith.
- e. It may please be noted that **No TA/DA** will be paid for attending the Document Verification.

## **6. METHOD OF SELECTION**

- a. Based on the online applications data, candidates will be called for original documents verification at CLDC-ECIL Hyderabad.
- b. **The candidates called for document verification shall require to present the following original documents mandatorily with a set of photocopies at the time of certificate verification:**
  - i. Online registered application form duly signed by the candidate and with recent color passport size photo affixed.
  - ii. All original certificates in support of NATS Registration, his / her date of birth, identity (Govt. issued only like Aadhaar, Driving License, Passport etc.), Educational Qualification, Latest Caste & Disability (PwD) certificates (wherever applicable).
  - iii. Category Certificate in support of SC/ST/OBC (Non-Creamy Layer)/EWS, in the prescribed proforma as hosted on [www.ecil.co.in](http://www.ecil.co.in) portal.
- c. After successful document verification, Apprentices selections will be done based on the qualifying examination marks merit (i.e. B.E./B.Tech. consolidated marks for GEAs and Diploma consolidated marks for Diploma Apprentices). **In case of CGPA, relevant CGPA topercentage conversion certificate from the college/university should be produced by the candidate.**
