Airports Authority of India (AAI) (Schedule – ‘A’ Miniratna Category-1 Public Sector Enterprise) was constituted by an Act of Parliament and came into being on 1st April, 1995 by merging erstwhile National Airports Authority and International Airports Authority of India. The merger brought into existence a single Organization entrusted with the responsibility of creating, upgrading, maintaining and managing civil aviation infrastructure both on the ground and air space in the country.

B. Educational Qualification:

- (i) Technical : Candidates should possess full time regular four years degree in Engineering or regular three years diploma of the above mentioned streams, recognized by AICTE, GOI.
- (j) General Stream : Regular/correspondence/distance three years degree from a recognized university.

C. Conditions:

1. Apprentices shall have to undergo Apprenticeship training at RCDU/FIU/CRSD & E&M Workshop & its related units – Safdarjung Airport, New Delhi – 110003.
2. As per the provisions of the Apprentices Act, 1961 as amended from time to time, candidates who have already completed their apprenticeship or terminated their apprenticeship midway or are pursuing in other organizations or in AAI with the same qualification level or otherwise, are not eligible for engagement as apprentice.
3. As per the Apprentices Act, 1961, candidates who had job experience / training for a period of 1 year or more after the attainment of essential educational / professional / technical qualifications, are not eligible for engagement as apprentice.

D. Mode of Selection:

1. **Interview-cum-documents verification on 27.03.2026 from 1000 hrs to 1800 hrs.**
2. Provisional selection of the candidates would be merit-based & the decision of AAI shall be final and binding.
3. The final selection will be based on Interaction /verification of certificates/testimonials and submission of Medical Fitness Certificate at the time of joining.
4. **The shortlisted candidates will be called for Interaction/Document verification through their registered email IDs only, so always keep their email id active and regularly check their emails in Inbox & Spam Folder**
5. The selected candidates will be posted preferably at various Establishment in RCDU/FIU / CRSD & E&M Workshop & its related unit at Safdarjung Airport, New Delhi – 110003.

 2. Candidates passed degree/diploma **in 2021 or after 2021** only are eligible.

After successful application, the message "Successfully applied for the training position. Based on availability, you will be contacted by the establishment" will appear. In case of general stream candidates, initially they will register themselves on NATS Portal and then may please submit their application on ipaggarwal@aai.aero. The attachment strictly be in a single PDF File only.
 4. **Candidates should register themselves with the concerned portal (NATS) prior to applying for apprenticeship training in AAI without fail.** Correspondence/Communication in any other manner will not be entertained. **[ANNEXURE – 1]**
 5. No TA/DA will be provided. The no. of candidates to be engaged is indicative and may undergo changes without any further notification at the direction of AAI & the decision of AAI shall be final & binding. AAI may also consider interchangeability of apprentices between Degree & Diploma courses.

6. During the period of apprenticeship, candidates will be governed by the Apprentices Act, 1961 (as amended in 1973 and till date) and the policies/rules of the organization.
7. Reservation for SC/ST, OBC and EWS as applicable will be followed, however, in case of non-availability of candidates in reserved category it will be filled from other reserved categories/general categories as the case be.
8. **Airports Authority of India has no obligation to give regular or contractual employment to Apprentices.** They shall have no right to claim regular or contractual employment from AAI on the basis of this apprenticeship at any point of time. This training program shall not create any liability on AAI for providing any job to the Apprentice. AAI management does not take any responsibility for any sort of employment/placement.
