**IMPORTANT NOTES & CHECKLIST OF DOCUMENTS TO BE SUBMITTED DURING DOCUMENT VERIFICATION & SPPT**

- The candidates have to ensure that they fulfill each of the eligibility criteria stipulated in our published common advertisement no. GR/Rectt/25 dated 20.12.2025 & thereafter hosted on our website www.iocl.com relating to age, qualification (along with minimum % marks in aggregate) as on the date of reckoning. In case they do not meet the above criteria, {including minimum % marks in aggregate as mentioned in Clause B.1(vi) of aforesaid advertisement}, they are directed not to appear in the SKILL / PROFICIENCY / PHYSICAL TEST (SPPT).
- In case during subsequent verification of certificates / testimonials (including mark sheets), contradiction to the claim in the on-line application or any time thereafter is found, the candidature will be summarily rejected at any stage of selection process without any further notice.
- The Application Nos. mentioned above are not in order of merit.
- Shortlisting of the candidates for the Skill / Proficiency / Physical Test does not confer any right for Selection as Non-Executive.
- Candidates who are currently employed in Government organizations, Government Departments, PSUs, or Autonomous Bodies must submit a **No Objection Certificate (NOC)** at the time of the Skill/Proficiency/Physical Test **failing which they will not be allowed to appear in SPPT.**
- All the above shortlisted candidates shall bring Print out of on-line application form, duly signed, copy of the Admit Card/ Call Letter of CBT retained by them and following **original documents along with self-attested copies of the same** at the time of Document Verification and Skill/Proficiency/Physical Test (SPPT), failing which they will not be allowed to appear in the SPPT:

v	SC/ST/ Disability Certificate/ UDID Card/ OBC (NCL) Certificate alongwith "Declaration" / EWS-Income & Asset Certificate. Certificate must be in the prescribed format (available on 'Latest Job Opening' under 'IndianOil for Careers' page of website www.iocl.com )and issued by the Competent Authority.
vi	For <b>Post Code-202: Junior Engineering Assistant-IV (P&amp;U):</b> At the time of SPPT, candidates possessing a <b>National Apprenticeship Certificate (NAC)</b> in Boiler Attendant under the Apprentices Act, 1961 must <b>MANDATORILY</b> produce <b>NAC with due endorsement of equivalence to the 2nd class Boiler Attendant Certificate of Competency by the competent Boiler Authority of the State</b> of Assam {against Guwahati Refinery}.
vii	For candidates applying for Post code 208, Sub Officers' Course passing certificate and marksheet along with Valid Heavy Vehicle Driving License.
viii	Proof of Qualification (equivalence), Self-Declaration of same area of work experience, Service Certificate, Discharge Certificate in case of Ex-Servicemen.
ix	Proof of Qualification (equivalence), Service Certificate , Discharge Certificate in case of Ex-Servicemen.
x	Duly completed Proforma of Certificate for employed Officials - for candidates belonging to ExServicemen, as applicable {Please refer to Clause No. C (6)} of the advertisement.

xi	Duly completed Form of Undertaking to be given by Candidates Applying for Civil Posts under Ex Servicemen Category- for candidates belonging to Ex-Servicemen, as applicable {Please refer to Clause No. C (7)} of the advertisement.

In case of mismatch in the date of birth mentioned in the Admission Certificate/Admit card and photo ID/ Certificate brought in support of date of birth, the candidate will not be allowed to appear in the examination.)
