Interested ITI holders' candidates are requested to apply online on <https://apprenticeshipindia.gov.in> (NAPS) portal and Graduate/Degree/Diploma candidates are requested to apply online on <https://nats.education.gov.in> (NATS) portal w.e.f 14.07.2026 up to closing date i.e. 10.08.2026.

1. Receipt of applications: Applications must be received online by the concerned w.e.f 14.07.2026 to 10.08.2026 through the following portal:-

- For ITI trades-** National Apprenticeship Promotion Scheme(NAPS)(<https://apprenticeshipindia.gov.in>)
- ii. For Graduate/Degree/Diploma Trades-** National Apprenticeship Promotion Scheme(NAPS)(<https://nats.education.gov.in>)

No other mode of application will be accepted.

2. Eligibility Criteria:

A. For ITI Trade Apprentices:

- The candidate must have passed 10th class examination with minimum 40% marks, from recognized Board and also possess National Trade certificate in the notified trade issued by the National Council for Vocational Training/State Council for vocational Training in respective trade.
- The candidate must have completed the relevant ITI course.
- The candidate must have Aadhaar Card(compulsory), which is required for online registration.

B. For Graduate Apprentice:

- The candidate must have Completed his/her Graduation or equivalent in the concerned Streams with minimum 40% marks, from recognized Institute.
- The candidate must have Aadhaar Card(compulsory), which is required for online registration.

C. For Diploma Apprentices:

- The candidate must have Completed his/her Diploma with minimum 40% marks, from recognized Institute.
- The candidate must have Aadhaar Card(compulsory), which is required for online registration.

Note: 1. There shall be **No** interview and **No** written exam.

3. Selection Process:

Eligible candidates shall be selected from the apprenticeship portal Database (NAPS/NATS). Selection shall be based on merit list prepared for all applicants. The merit list will be prepared on the basis of percentage of marks in matriculation 10th, 12th and ITI course/Diploma/Graduate Degree/Post Graduate as per following details: -

4. Preference in Selection: Based on merit criteria outlined in the advertisement, preference for selection of apprentices will be given as under: -

- A. 25% Seats out of total available seats for each trade will be given to candidates possessing the residency certificate of the concerned districts of the State where the Project/Power Station/Unit is located.
- i. Should the reserved seats still persist, then these seats will be given to candidates possessing the residency certificate of the States where the Project/Power Station/Unit is located.
- ii. Should the above- mentioned reserved Seats still persist, the remaining seats shall be filled through open Merit.

Note: Project Areas/Sub-Stations area that shall be considered are as under:

- I. Bhakra & Nangal Dam Project- Ropar, Bilaspur and Una.
- B. In case of two candidates having the same marks, the candidates with older age shall be given preference.
- C. In case the dates of birth are also same, then the candidate who passed matriculation exam earlier shall be considered first.

5. Reservation: Reservation shall be as per Apprentice Act 1961 and its amendments from time to time

6. Age: As per Apprenticeship Act 1961 and its amendments from time to time.

7. Documentation: Short listed candidates shall be called for verification of following documentation: -

- i. 10th Mark sheet.
- II. ITI Certificate & Marksheet (certificate should be duly Issued by NCVT/SCVT)
- III. Category certificate (SC/ST/OBC if applicable).
- IV. Residence/Domicile certificate if applicable.
- V. Aadhaar Card.

8. General Guidelines: Following guidelines are also to be considered.

- i. Candidates whose results are still awaited on the last date of receipt of applications for the qualifying examinations as mentioned in eligibility criteria will not be considered.
- ii. Selection and deployment of apprentices shall be subjected to detailed provision of Apprenticeship Act 1961 and its time-to-time amendments if any.
- iii. Result of engagement of apprentices shall be uploaded on BBMB websites through the office of System Software manager, BBMB, Chandigarh.
- iii. Candidates, who after completion of their education have undergone apprenticeship training or undergoing apprenticeship training in any other establishment under Apprenticeship Act 1961, are not to apply for apprenticeship training.
- iv. The selection and deployment of Apprentice Trainee will be subject to detailed provisions of Apprenticeship Act. The Contracts with candidates thus selected will be registered under NAPS/NATS Portal. Therefore, candidate who have already been registered and got training under these schemes will not be entertained and need not apply.
- v. Incomplete application in any manner will be rejected without assigning any reason.
- vi. Date and time for document verification will be decided by this office and if any candidate at the time of document verification is found absent his/her application will not be considered without assigning any reason.
