Subject: Declaration of results of UGC – NET December 2024 – reg.

1. The UGC – NET December 2024 examination was conducted by National Testing Agency for 85 subjects in computer based test (CBT), mode. The examination spanned over 09 days and was conducted in 16 shifts at 558 exam centres in 266 cities across the country for 8,49,166 candidates, as per the following details:

In order to make the examination system transparent, the Question Paper, Provisional Answer Key(s) and Recorded Responses of the concerned candidates for UGC – NET December 2024 Examination were hosted on the NTA website <https://ugcnet.nta.ac.in/> from 31st January 2025 to 03rd February 2025 to invite challenges. Challenges received were verified by the experts and results were processed as per the answer keys finalized by experts.

4. The result of UGC-NET December 2024 examination is being declared today i.e. (22.02.2025).

6. Measures for Smooth & Fair Conduct of Examination:


A control room was opened in the NTA premises where Virtual Observers were deployed for monitoring of live CCTV of all examination centres in India. A total of approximately 35,000 cameras were installed. In order to stop cheating using mobile networks, jammers were installed in all the centres to prevent unfair practice by the candidates during the examination. approx. 40,000 jammers in all shifts were put in place.
