If it is found that any candidate is not fulfilling the conditions as per AEES Recruitment Notice No. AEES/02/2024, his/her candidature is liable to be terminated/cancelled at any time.

4. The candidates are liable to serve in any of the 30 AEC Schools situated all over India, as required by AEES from time to time.
  5. The aforesaid panels are valid till 27/02/2026 or till the preparation of the next panel, whichever is earlier. AEES, however, reserves the right to extend the validity of the panel in order to fill the advertised vacancies, from among the candidates empanelled in table above.
