In case suitable Economically Weaker Section (EWSs) candidates are not found, these posts will neither be carried forward nor considered as backlog vacancies. - 1. Retired Faculty from Institutes of National Importance (INIs) and Government Medical College (GMCs) at the level of Professor, Additional Professor and Associate Professor up to age of 70 years are eligible for applying on contract basis.
- 2. Retired Faculty from Armed Forces Medical Service (AFMS) at the level of Professor, Additional Professor and Associate Professor up to age of 70 years are encouraged to apply on contract basis under Scheme for Re-deployment of Superannuated Teachers of the AFMS (SRESTA).
- 3. Applicants who fulfil the above qualifications/eligibility may submit Application form as per the procedure given in General Conditions.

4. Remuneration:

- vi. Retired Faculty Consultant will be eligible for thirty (30) days leave in a calendar year, on cumulative basis.
- vii. During the period of contract, the engagement is liable to be terminated at any time with a one-month notice, without assigning any reason whatsoever.
