## PROVISIONAL RESULT

The Screening test for the Posts of Assistant Professor (College Cadre) – Political Science in (Advt No. 62/2024) in Higher Education Department was conducted by the Haryana Public Service Commission on dated 18.05.2025. ## Note:

- 1. While preparing the result, due care has been taken. However, possibility of any inadvertent error cannot be ruled out. The Commission reserves its right to rectify any error at a later stage.
- 2. The twenty one (21) Candidates bearing Roll Nos. 70549, 70552, 71551, 72159, 72325, 72457, 72564, 73019, 74097, 74873, 75451, 75571, 75734, 76141, 76142, 76484, 76657, 76717, 77951, 78340 & 78508 belonging to the categories other than General/UR category have been shortlisted against the posts meant for General/UR category in pursuance of the orders dated 09.04.2025 passed by the Hon'ble Punjab & Haryana High Court in LPA No. 329/2024. The aforementioned candidates are directed to furnish the documentary proof of having qualified the National Eligibility Test for Assistant Professors in the General/UR category in the format enclosed. These twenty one (21) candidates are directed to appear in the Commission's office at 10:00 AM on 06.06.2025 alongwith all documentary proof regarding all eligibility conditions i.e. Age, Educational Qualifications, Good academic record meant for the General/UR category including National Eligibility Test for Assistant Professors qualified by them is in the General/UR category such as (a) NET certificate, (b) NET mark sheet, (c) Category-wise cut-off marks for the said NET exam etc.

- 3. In case any of the above twenty one (21) candidates are not able to prove their eligibility for the General/UR posts, they will stand shifted to their respective categories & result will be revised accordingly.
- 4. The candidates who fail to appear in the Commission's office on the scheduled date and time to prove their eligibility for a General/UR post, then the Commission will take a decision regarding their eligibility with respect to General/UR category based on their available record.

- 5. The break-up of ESM-SC posts has not yet been received from the Department of Higher Education, Govt. of Haryana. Hence, candidate bearing Roll No. 70988 belonging to DSC category has been provisionally shortlisted for the next stage of examination. In case, there is no post allocated to ESM/DESM-DSC of Haryana, the candidature of Roll no. 70988 for the next stage of the exam shall stand withdraw.
- 6. The above result is subject to final outcome of the CWP Nos. 13329/2025, 21663/2024, 6455/2025 & 7073/2025 pending before the Hon'ble High Court.
- 7. As per the instructions for the candidates issued with the Admit Card, as well as instructions given on the question booklet and the OMR sheets, it is mentioned that:
  - i. "Any omission or discrepancy in filling the Roll Number, Question Booklet Series and Question Booklet Number will render the OMR Answer Sheet liable for rejection".
  - ii. Any candidate not darkening any of the five circles in more than 10% question shall be disqualified.

Hence thereof, the OMR Sheets of 45 candidates have been rejected. These OMR sheets are also being uploaded on the Commission's website.
