### **Process to view Response Sheet/ Answer Keys and raise Objection(s)**

Steps to be followed to view Response Sheet/ Answer Keys:

- Please log in to OSSSC web portal using your User ID & Password
- Click on "View Response Sheet, Answer Keys & filing Objection to the Answer Keys"
- Enter your "Application No" & "Date Of Birth" in "DDMMYYYY" format (If your date of birth is 1<sup>st</sup> of May 2000, enter Date of Birth as 01052000)
- "APPLICANT DETAILS" page will open along with "Candidate Personal Details"
- Click on "CANDIDATE RESPONSE"
- Click on "**here**" in "To download your Answer Key for Assessment. Click here to generate it." to view your response sheet. (Correct answer will be visible in green colour and your response will be visible on the right side with option ID's )

Steps to be followed to raise Objection(s):

- Click on "OBJECTION FORM"
- Click in "Click here to raise an objection".
- FORM TO RAISE OBJECTION page will open(Note: Read the instructions carefully to raise objection).
- On the main Screen "Candidate's Registration No", "Name", "Post Name", "Date of Exam", "Shift" will be shown auto filled. Candidate must select the "Question Id" "Language" & "Nature of Objection".
- Under "Do you want to add remarks", Click "Yes" if you want to add any remarks.
- You must upload valid documents in support of your objection by clicking on "Click here to upload documents button"
- Once uploaded, click on "Submit"

**Note:** Candidates can raise more than one objections by following similar process.
