In case of Non-availability of candidates for faculty positions in a particular reserved category, the available meritorious candidate may be given offer of engagement for a period of 44 days at the sole discretion of the Appointing Authority.

Note 2:

Upgradation of Posts to comply with NMC norms: -

1. Candidates with eligibility for a higher post, i.e. Professor, would be permitted to be interviewed against a lower post, i.e. Associate Professor.
2. In event of selection of such candidates, the candidate would be considered for placement with suitable upgradation of the lower post as per eligibility and recommendation of the selection board.
3. The upgradation would be temporary and limited to the tenure of the teaching faculty / until the appointment of regular incumbent in the lower post.
4. The above upgradation post will be applicable at the sole discretion of the Appointing Authority.

Note 3:

Note:

Only when there is no person with benchmark disability available for the post, the employer shall fill up the vacancy by engagement of a person, other than a person with benchmark disability, vide office memorandum dated 15.01.2018.

The person who suffers from not less than 40% of disability will only be eligible for the benefit of reservation and other relaxations under PWD category as permissible under the rule. Important Instructions:-

1. 2. **Only those candidates whose documents are verified will be allowed to attend walk-in interview.**
3. **3 Posts** are horizontally reserved for PwD category in identified posts only.
4. Dean, ESIC Medical College & Hospital reserves the right to vary these vacancies including increase or decrease or cancellation of filling up of any or all posts without assigning any reason.

5. Change in date of interview, etc. if any, will be intimated on website only. Candidates are advised to check the website regularly for any updated information relating to the recruitment. Other terms and conditions as mentioned in **Annexure 'A'**.
6. Retired/resigned/voluntarily retired faculty members from Government or other Medical Colleges may be considered for re-engagement on the same designation.

- B. Age Limit: Not exceeding 68 years as on date of interview.

General Terms and Conditions for Teaching Faculty

Terms of Contract:

1. The contract would initially for a period of three years at the outset, with a provision of further extension for a period of two years subject to annual renewal of tenure based on Review of Performance. The maximum tenure of such engagement will not exceed 5 years or 70 years of the age of faculty, whichever is earlier.
2. The contractual engagement will be subject to the following:
 - a. Barring serious misconduct/irregularity, continuation of the incumbent would be based on satisfactory annual appraisal.
 - b. The contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning any reason.
3. Rules for Reservation will be implemented as per Govt. of India instructions / guidelines.
4. The engagement shall not confer any right or preference for regular appointment.
5. No claim for any service benefits like PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.

6. Candidate must be registered with State Medical Council/NMC as applicable, before joining the post.
7. Candidate who are working in Central Government/State Government/Central Autonomous bodies/State Autonomous bodies/Central PSUs/State PSUs/have to produce no objection certificate from their employer at the time of document verification / Interview.
8. The candidates who are already employed must produce relieving order from the previous employer at the time of joining / NOC for taking up engagement with ESIC.
9. No TA/DA will be admissible for interview or joining.
10. ESI Corporation may increase or decrease or cancel filling up of any or all posts without assigning any reason at the discretion of the Appointing Authority.
11. Candidates applying in **OBC/SC/ST/EWS/PWD** Category must possess the certificate issued by competent authority, valid for admission/ job in Central Govt. Institutions issued before the date of interview, failing which **he/she shall not be allowed to appear in interview for the reserved category.** However, he/she can be treated as UR Candidate.
12. The candidates claiming reservation on grounds of belonging to **OBC [non-creamy layer]** should submit the community certificate in Annexure “A” prescribed vide Govt. of India, Department of Personnel and Training O.M No. 36036/2/2013-Estt (Res) dated 30.05.2014 failing which the benefits of reservation will not be given and their application shall be rejected and no request /correspondence will be entertained. **Certificate issued in other formats will not be accepted and the candidature will be treated as “General Category” for all purposes.**
13. The candidates engaged under PWD quota will be adjusted against the vacancy of respective categories of SC/ST/OBC and UR quota. The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Government Hospitals/Institutions.
14. **In case of non-availability of candidates for faculty position in a particular reserved category, the available meritorious candidate may be given offer of engagement for a period of 44 days at the sole discretion of the Appointing Authority.**
15. The Dean has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of engagement.
16. The Teaching Faculty so selected will be required to submit unconditional acceptance/consent letter in writing before appearing for medical examination.
17. The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice and without payment in lieu of the notice period.
18. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on Aadhar Enabled Bio-metric Attendance System (AEBAS) daily during scheduled working days.
19. They will also be required to attend emergency, floor duty and other clinical duty as assigned by the Competent Authority.

20. They will also be required to perform duties in other departments as assigned by the competent authority.
21. Selected candidates will have to join duty on or before the date indicated in the offer of engagement likely to be issued.
22. The Teaching Faculty so engaged will be required to enter into a contractual agreement for the purpose on a **stamp paper of Rs.100/-**.
23. EWS candidate appearing for the post must have EWS certificate as per Govt. prescribed format and valid on the date of interview.
