ODISHA TEACHERS ELIGIBILITY TEST(OTET), 2025

It is for information of all concerned that the provisional 'Answer Keys of OTET, 2025 held on 17/12/2025 is available in the website www.bseodisha.ac.in giving opportunity to the candidates for challenge in case they feel any ambiguity in the answers.

The candidates are free to make online challenge on visiting the website www.bseodisha.ac.in against the responses given in the answer key on payment of Rs.500/- per each response. They can upload authentic documents in support of their challenges which will be examined and analysed by the Question Analysis Committee of the Board. Final Answer keys of OTET, 2025 will be hoisted after detail analysis of the challenged responses by the said committee. The result shall be processed on the basis of the final answer keys as decided by the Committee. The decision of the Question Analysis Committee shall be final and binding on the candidates.

The online challenge of Answer Keys link will be available (24 x 7) from 29/12/2025 11.00 am to 04/01/2026 midnight. The candidates shall deposit the fee as well as submit the online application form by 04/01/2026 midnight. Under no circumstances last date fixed above shall be extended.

Application for challenge shall be accepted only in **ONLINE MODE** with the stipulated period as above. No other mode of submission such as through E-mail/ Postal Despatch/ Personal Delivery shall be entertained. Full amount per response will be refunded to candidate through online transfer in his/ her saving bank account, if the challenge is accepted by the Board. Proactive disclosure of all information U/s of the RTI Act, has been made for information of all concerned.
