1. Applications are invited through online mode for recruitment to the post of Assistant Professors in Clinical, Non Clinical and Super Specialties in the institutions under the control of Directorate of Medical Education through the Lateral Entry.
2. Candidates shall apply online through DME Website <https://dme.ap.nic.in> and <https://dmeaponline.com>.

**Note:**

- i. Applicants are advised to retain their registered mobile number and Email ID to receive SMS and Communication Updates if any.
- ii. SC Sub-classification is applicable. SC applicants must clearly specify their Group: SC (Group-I), SC (Group-II) or SC (Group-III).
3. Applicants must regularly visit the APMSRB website and DME Website to stay updated throughout the recruitment process. The MSRB website will serve as the sole source of official communication. No individual correspondence will be entertained under any circumstances.
4. All eligible and interested candidates must apply online after satisfying themselves about the terms and conditions of this recruitment. Applications submitted through any mode other than online will not be entertained. Submission of the online application implies that the candidate has read and agrees to abide by the terms and conditions laid out in this notification.

**6. Educational Qualifications :**

The candidate should possess the prescribed academic qualification as on the date of this notification. The date of this notification shall be the crucial date for calculating the weightage marks if any.

**7. Reservations:**

There will be Vertical Reservations in respect of Scheduled Tribes, Scheduled Castes, Horizontal Reservations in respect of Women and Persons with Benchmark Disabilities (PBD) as per Rule 22, 22(A) and 22(B) of A.P. State and Subordinate Service Rules, 1996 as amended vide G.O.Ms.No.77, G.A. (Ser-D) Dept., Dt: 02.08.2023, G.O.Ms.No.03, G.A. (Ser-D) Dept., Dt: 17.01.2024, G.O.Ms. No.7, SW (CV) Dept., Dt: 18.04.2025 and G.O.Ms.No.46, GA (Ser-D) Dept., Dt: 19.04.2025.

## **8. FOR THE CANDIDATES APPLYING UNDER LATERAL ENTRY**

### **1. Eligibility Criteria :**

- a. Assistant Professors in broad specialties working in Directorate of Medical Education, Civil Assistant Surgeons working in the Directorate of Public Health & Family Welfare or Directorate of Secondary Health (APVVP) are only eligible to apply.
  - b. Candidate shall be an approved probationer or should have completed the probation period in the cadre of CAS/ Assistant Professor.
  - c. There shall not be any disciplinary charges pending against the candidate and shall not be in unauthorized absence.
2. Rule of Reservation applicable to the promotions is adhered to, in the recruitment through lateral entry.
  3. Candidate applying for Lateral Entry shall submit NOC from the HoD in the prescribed format at **ANNEXURE No.IV**
  4. For the Candidates applying under Lateral Entry, do not require Senior Residency. After selection, they will be posted as Senior Resident for a period of one year and after completion of one year SR ship, they will be appointed as Assistant Professor.

### **9. Selection Procedure for LE:**

- a) Merit list will be prepared based on the rank given by the respective appointing authority at the time of recruitment as CAS / Assistant professor.
- b) Selection list will be prepared based on merit and the rule of reservation applicable to the promotions as per AP state and subordinate service rules.
- c) The decision of the Medical Services Recruitment Board in all aspects and all respects pertaining to the application and its acceptance or rejection as the case may be, the selection or otherwise of any candidate shall be final in all respects and binding on all concerned.

## **10. HOW TO APPLY:**

Applicant must pay **Rs: 2000/- for OC category** and **Rs: 1500/- for SC,ST,BC,EWS and Persons with benchmark disability**) through payment gateway which was provided in the application module.

- 1) Applications must be submitted online through <https://dme.ap.nic.in> and <https://dmeaponline.com/> From **12.01.2026 to 27.01.2026 up to 11.59 pm.**
- 2) Applicants should upload all required certificates
- 3) Upon submission of online form, Notification wise Application Number will be generated. The same may be used for any future reference.
- 4) Applicant must compulsorily fill-up all relevant columns of the application form carefully. The applicant alone shall be responsible for information provided by him/her.
- 5) Incomplete/ incorrect application form will be rejected. The information if any furnished by the applicant subsequently in any form will not be entertained by the APMSRB under any circumstances.
- 6) The applicant should not furnish any particulars that are false, tampered, fabricated, or suppress any material information while submitting online application. The applicant shall be liable for legal action in such cases.

## **11. Certificates to be uploaded Online:**

- Before applying for the posts online, applicants are requested to keep the soft copy (PDF) of the following documents ready for uploading:

- g) Must submit the 1<sup>st</sup> Appointment order, Rank and Date of joining copy.
- h) Copy of Probation Declaration order.
- i) No Charges pending certificate from the appointing authority.
- j) NOC from the appointing authority in the format at **Annexure IV**
- k) Declaration given in **Annexure V** must be submitted by the candidate duly filled and signed\*.
- l) Candidates already working as Assistant Professors under Director of Medical Education are not eligible for same specialty.
- m) Candidates who claim under Differently Abled category must submit relevant certificate to that extent, issued by concerned Medical Board or SADAREM.
- n) Caste Certificate in case of SC/ST Certificate issued by Competent authority. If caste certificate is NOT submitted, then such candidate will be considered as OC.
- o) Applicants belonging to Schedule Classes are required to produce Community Certificate (SC-I, SC-II and SC-III) issued by the Competent Authority of Government of Andhra Pradesh.
- p) Certificate of Marks Memo shall be mandatorily uploaded online along with the application.
- q) No certificate or paper will be accepted after submission of online application.
- r) No application will be accepted in any mode other than ONLINE.
- s) All are informed that the various conditions and criterion prescribed herein are Governed by the General rules of A.P. State and Subordinate Service Rules, 1996 read with the relevant specific rules applicable to any particular service in the Departments, any guidelines or clarification is based on the said rules, and in case of any necessity, any matter will be processed as per the relevant general and special rules in force.

## **12. General Instructions:**

- a) Required original certificates should be submitted at the time of verification of certificates or whenever called for. Failure to produce the required original certificates will lead to disqualification.
- b) The claim of the applicants with regard to the date of birth, educational qualifications and community etc., are accepted provisionally on the basis of information furnished by them in their application form and is subject to verification and satisfaction of the APMSRB. Mere inclusion of the name of an applicant in the Merit List will not confer any right for appointment. The candidature is therefore, provisional at all stages and the APMSRB reserves the right to reject candidature at any stage of the selection even after declaration of results/appointment, if any mistake is noticed at a later date.
- c) Printout of downloaded application form as well as original certificates / documents as mentioned at Para (13) have to be submitted at the time of certificate verification.
- d) All desirous and eligible candidates shall apply online after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification. Any application sent through any mode other than online mode will not be entertained under any circumstances. Submission of the application form by the candidate is an authentication that he/she has read the notification and shall abide by the terms and conditions laid down there under.
- e) Applicants should make sure of their eligibility to the posts applied for and that the declaration made by them in the application form regarding their eligibility is correct in all respects. Any applicant furnishing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from appearing for any of the examinations conducted by the APMSRB, and for summary rejection of candidature for this

recruitment.

- f) The Board is vested with the duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process. Any attempt by anyone causing or likely to cause breach of this duty or by any action which violates or is likely to violate fair practices followed and ensured by the Board will be sufficient cause for rendering such action as ground for debarment and penal consequences as per law and rules shall be involved as may be decided by the APMSRB.
- g) If any applicant is or has been found impersonating or resorting to any other irregular or improper means in connection with his / her candidature for selection or obtaining support of candidature by any means, such an applicant may in addition to rendering himself/ herself liable to criminal prosecution, will be debarred permanently from any exam or selection.
- h) If an applicant himself/ herself or through relations or friends or any others has canvassed or endeavored to enlist for his/her candidature, whether from official or non-official sources, for appointment to any State Service or Subordinate Service shall be disqualified.
- i) Applicants are directed to (<https://apmsrb.ap.gov.in/msrb/> visit the Board's Website) regularly to know the latest developments of this recruitment and any changes/ modifications/ results/ calling of applicants for verification of Certificates etc. Applicants may note that individual communication shall not be made.
