1. **Applications along with the prescribed application fee are to be submitted online mode through CU-Chayan portal i.e. <https://curec.samarth.ac.in>.**
2. **Submission of hard copy of application is mandatory.** Candidates have to submit hard copy of the application (single copy) along with the copies of all self-attested documents having proper serial numbers as claimed by them in the online application. However, the legible copies of the documents uploaded by the candidate on CU-Chayan portal will be treated as final. Hard copy of the application shall be submitted in **"Recruitment & Promotion Section (Teaching), 2nd Floor, Registrar's Office, Jamia Millia Islamia, Jamia Nagar, New Delhi-110025"** by **23.04.2026**.
3. Qualifications, experience, etc. will be reckoned as on the last date for receipt of filled-in applications i.e. **13.04.2026**. The University will not be responsible for any postal delay in case of receipt of application forms.
4. The Academic score as specified for Asstt. Professor in Appendix II (Table 3A) for Universities shall be considered for short-listing of the candidates for interview only. The Selections shall be based only on the performance in the interview for all categories.
5. Selection against temporary post/vacancy shall not confer on the appointee any right of permanent appointment/regularization.
6. The proof of peer-reviewed journal status, impact factor, authorship claim etc. should be provided with valid documents, otherwise the marks will not be allotted as per the claim. University will not be responsible for any mistakes made due to not providing valid proof.
