

AFFIDAVIT

(To be executed on a Non-Judicial Stamp Paper of ₹100/- and duly attested by a Notary Public)

The _____ (hereinafter referred to as the "**Institution**"), through its duly authorized representatives, do hereby solemnly affirm, declare, and undertake as under:

1. That the Institution is duly recognized and authorized to conduct the approved Teacher Education Programme(s) and shall offer such programme(s) exclusively from the campus/premises for which recognition has been granted by the National Council for Teacher Education (NCTE).
2. That the Institution shall neither demand nor collect, directly or indirectly, any fee, donation, capitation fee, consideration, contribution, or charge of any nature whatsoever from any candidate other than the fee duly prescribed and approved by the competent authority, including the State Government and/or the Affiliating University.
3. That the Institution shall not admit, enroll, register, or otherwise grant admission to any candidate at its own level. All admissions to the Teacher Education Programme(s) shall be made strictly through the admission process prescribed by the PTET-2026 Office and in accordance with the applicable rules, regulations, eligibility conditions, and directions issued by the competent authorities from time to time.
4. That, as on the date of execution of this Affidavit, the recognition, approval, No Objection Certificate (NOC), affiliation, and all other statutory permissions required for conducting the Teacher Education Programme(s) for the Academic Session 2026-27 have been duly obtained from the NCTE, the State Government, and the Affiliating University, and that none of the same has been rejected, withdrawn, suspended, or remains pending before any competent authority.
5. That the Institution shall meticulously scrutinize and verify, in original, all documents submitted by candidates relating to educational qualifications, eligibility criteria, reservation status, domicile, category claims, and any other requirement prescribed under the applicable rules and regulations. The Institution shall be solely responsible for the correctness and authenticity of such verification and shall return the original documents to the concerned candidates immediately after due verification.
6. That the Institution shall remain solely and exclusively responsible for any act of omission, commission, negligence, misrepresentation, concealment of material facts, submission of incorrect information, or violation of any provision contained in the applicable Acts, Statutes, Ordinances, Regulations, Notifications, Guidelines, Orders, Directions, or Instructions issued by the NCTE, the State Government, the Affiliating University, the PTET-2026 Office, or any other competent authority.
7. That the Institution unequivocally undertakes to comply with and abide by all admission norms, procedures, regulations, guidelines, and directions issued by the NCTE, the State Government, the Affiliating University, and the PTET-2026 Office from time to time. In the event that the recognition, approval, affiliation, or permission of the Institution is withdrawn, suspended, cancelled, or otherwise rendered inoperative by any competent authority at any stage, including after completion of admissions, the PTET-2026 Office shall be fully empowered to transfer the admitted candidates to any other recognized institution, and the Institution shall not raise any objection, claim, dispute, or demand in relation thereto.
8. That the Institution shall indemnify and keep indemnified the PTET-2026 Office, the State Government, the Affiliating University, and all their officers and representatives against any loss, liability, claim, litigation, proceeding, penalty, cost, or consequence arising directly or indirectly from any breach of the undertakings, declarations, or obligations contained herein or from any violation of the applicable rules and regulations by the Institution.
9. That the Institution acknowledges that any false declaration, suppression of material information, or breach of any undertaking contained in this Affidavit shall render it liable for appropriate legal, administrative, financial, and regulatory action, including but not limited to cancellation of participation in the admission process, withdrawal of allotted candidates, and such other action as may be deemed fit by the competent authority.

The Institution hereby declares that the statements made hereinabove are true, correct, complete, and made in good faith. No material information has been concealed therefrom, and this Affidavit is being submitted voluntarily for the purpose of participation in the PTET-2026 admission process and for compliance with the directions issued by the competent authorities.
