

**PRESS RELEASE**

Recruitment to the posts of SCT Police Constable (Civil) (Men & Women), and SCT Police Constable (APSP) (Men) in Police Department was notified vide Notification Rc.No.161/SLPRB/Rect.2/2022, Dtd: 28-11-2022.

2. The Final Written Test was held on 01.06.2025 at 05 locations viz., Visakhapatnam, Kakinada, Guntur, Kurnool and Tirupati. The candidates are advised to download their data and marks obtained by them in the Final Written Examination from the website “www.slprb.ap.gov.in” from 10.07.2025 at 09.00 PM onwards. 5. The above facility will be available from 10-07-2025 to 12-07-2025 till 05.00 PM and the candidates will be informed the result of "verification" through SMS and e-mail. In case of any improvement in marks, the fee paid by such candidate's will be refunded by SLPRB, Andhra Pradesh.

6. Those who apply for Verification are informed that the OMR Sheet will be scanned once again and mark awarded will be checked as per the Final Answer Key released.

7. Candidates are requested to download Scanned copy of OMR Sheets and verify the marks awarded. They must mention specific reason while requesting for "Verification" so that their grievance may be looked into.
8. Each valid representation received with fee will only be examined and the decision of the committee in the matter shall be final. No further communication will be entertained after the last date. Incomplete representations will not be entertained.
9. Candidates can download their details and verify whether the information is correct or not. If, the data needs any correction (except post preferences and Unit Preferences), such candidates should send their requests along with relevant documents from their e-mail ID only to "apslprb.pcsobj2022@gmail.com" from 11-07-2025 to 17-07-2025. Request sent to any other e-mail ids or any other mode of communication i.e. Hard copies and etc., will not be entertained.
10. The e-mails which will be receiving after 17.07.2025 will not be entertained under any circumstances and they will be treated as "summarily rejected".
