Copies of the following documents must be uploaded in support of the information given in the Online Application Form where necessary as well as the documents in original should be produced at the time of Certificates verification. Failure to upload the same will lead to rejection of the Application Form.

- i. SSC / Matriculation Certificate or equivalent Certificate in support of Date of Birth
- ii. Educational Qualification Certificates pertaining to the relevant Post/s as per their eligibility (See Para No. 12A (C) and 12B (C) of this Notification)
- iii. Valid Heavy Passenger Motor Vehicle (HPMV) and Heavy Goods Vehicle (HGV) or Transport Vehicle Driving Licence for the Post code No. 45 i.e., Drivers (See Para No. 12A (D) of this Notification)
- iv. National Apprenticeship Certificate, if possessed by the Candidate, for the Post of Shramik (Post Code No. 46)
- v. Study Certificate(s) issued by the Government School Authorities / Government recognized School Authority (from 1st to 7th classes) or Residence Certificate issued by M R O (in case where the Candidate has not studied in any educational institution) for last 4 / 7 years stay prior to and inclusive of 7th Class (Annexure IX(A) or Annexure IX(B))
- vi. Latest Community Certificate issued by the competent authority of Government of Telangana. Candidates who belong to SC Category should submit Community Certificate as per Act No. 15 of 2025, dated 14-04-2025 issued by the Government of Telangana with regard to reservations to SCs by way of sub-classification in the State

- vii. Non Creamy Layer Certificate issued by the competent authority issued on or after 1st April 2025 (in case of BC candidates)
- viii. Certificate of Economically Weaker Section (EWS) category issued by the competent authorities issued on or after 1st April 2025 wherever applicable
 - ix. Meritorious Sports Person Certificate/s issued by the Sports Authority as per Annexure I of GO Ms No 74, YAT&C (Sports) Department, dated 09.08.2012 r/w GO Ms No. 5, YAT&C (Sports) Department, dated 14-05-2018 (Annexure X to Annexure XIII) wherever applicable
 - x. PPO (Pension Payment Order) / Discharge Book / NOC of Indian Army / Indian Navy / Indian Air Force wherever applicable (for Ex-servicemen)

9. RULES GOVERNING THE POST(S)

Telangana State Road Transport Corporation is a Public Sector Undertaking and the recruitment to the Posts of Drivers and Shramiks is being made as per the Regulations / Circulars / Standing Orders / Guidelines issued by TGSRTC from time to time.

10. SPECIAL REPRESENTATION (RESERVATION)

A) Reservation: The rule of Special Representation (Reservation) in terms of Rule 22 and 22 (A) of Telangana State & Subordinate Service Rules, 1996 which is adapted by TGSRTC, shall be applicable.

B) Community:

i) SC and ST Candidates, who are local Candidates to Telangana State as per the Regulation 8 of TGSRTC Recruitment Regulations, are required to produce latest Community Certificate issued by the Competent Authority of Government of Telangana State for claiming Age relaxation / reservation. Candidates who belong to SC Category should submit Community Certificate as per Act No. 15 of 2025, dated 14-04-2025 issued by the Government of Telangana with regard to reservations to SCs by way of sub-classification in the State. The SC Community Certificates issued before 14th April 2025 without SC Sub-Classification as per above Act shall not be considered for reservation under SC Category.

- ii) BC Candidates who are local Candidates to Telangana State as per the Regulation 8 of TGSRTC Recruitment Regulations, are required to produce Community Certificate (BC-A, BC-B, BC-C, BC-D or BC-E) from Competent Authority of the Telangana State Government.
- iii) Candidates belonging to Backward Classes shall submit the latest Community Certificate to claim Age relaxation and the latest Certificate of Non-Creamy Layer issued by the Competent Authorities of Telangana State on or after 1st April 2025 to claim Reservation. In case of failure to produce the Non-Creamy Layer Certificate on the day of Certificates Verification such Candidates, will be considered under "Open Competition", if otherwise eligible, and the status cannot be changed later.
- iv) Relaxation in upper age limit and / or reservation to BC-E Group will be subject to the adjudication of the litigation before the Honourable Courts including final orders in Civil Appeal No(s) 2628-2637 of 2010 in SLP No.7388-97 of 2010 dated 25-03-2010 and orders issued, if any, by the Government from time to time.
- v) BC, SC and ST Candidates who are not local to Telangana as per the Regulation 8 of TGSRTC Recruitment Regulations are not entitled for any kind of reservation.

C) Economically Weaker Section (EWS):

Candidates who are local Candidates to Telangana State as per the Regulation 8 of TGSRTC Recruitment Regulations and belonging to Economically Weaker Section category (as per GO Ms No. 65, GA (Ser. D) Department, dated 19.03.2021 r/w GO Ms No. 244, GA (Ser. D) Department, dated 24-08-2021) shall submit the Income and Asset Certificate issued by any of the following Authorities of Government of Telangana State to claim Age relaxation and Reservation under this Category.

- i) District Magistrate / Additional District Magistrate / Collector / Sub-divisional Magistrate / Mandal Revenue Officer
- ii) Revenue Officer not below the rank of Tahsildar and
- iii) Sub-Divisional Officer of the area where the Candidate and / or his family normally resides

D) Meritorious Sports Person (MSP):

Reservation to Meritorious Sports Persons is applicable as per GO Ms No.107 dated 27-07-2018 of General Administration (Ser.D) Department which is adapted by TGSRTC. In implementing this reservation, GO Ms No. 74 dated 09.08.2012 of YAT&C (Sports) Department r/w GO Ms No. 5 dated 14-05-2018 of YAT&C (Sports) Department, will be followed. In the event of non-availability of eligible Sports Persons, the Posts reserved for them will be allotted to Open Competition in the same recruitment. Candidates who obtain Form–1 (or) Form–2 (or) Form–3 along with Participation Certificate/s are eligible under this reservation for the Post of Drivers and Candidates who obtain Form–1 (or) Form–2 (or) Form–4 along with Participation Certificate/s are eligible under this reservation for the Post of Shramiks.

Note: Candidates who come under Form-1 above shall be considered initially to fill the vacancies under MSP reservation. If sufficient Candidates of Form-1 are not available, then Candidates from Form-2 and thereafter from Form3 / Form-4 shall be considered.

E) Women Reservation:

33½% of the vacancies in each category are reserved for Women under Direct Recruitment on horizontal basis as per GO Ms No. 35, GA (Ser.D) Department, dated 13-02-2024 which is adapted by TGSRTC. Reservation for Women will be a horizontal reservation following the principle of sufficiency i.e., reservation of Women Candidates shall be adjusted proportionately in the respective category to which the Woman Candidate belongs. In the event of non-availability of eligible and suitable Women Candidates, the vacancies reserved for them shall not be carried forward for the succeeding recruitment and shall be filled up by Men Candidates of respective Community Category in the same recruitment. The Government have exempted from providing 33⅓% reservation to Women Candidates for the recruitment to the Post of Shramik and the selection of Men and Women Candidates for this Post shall be based on Merit only.

11. INSTRUCTIONS TO BE READ CAREFULLY

The requisite Educational Qualification, Age, Physical Standards, Procedure to be followed for selection etc., are given below. Candidates must read the instructions given in this Notification carefully in their own interest.

12A. ELIGIBILITY CONDITIONS FOR DRIVERS (POST CODE 45)

A. Gender: Men and Women are eligible for the Post of Drivers.

B. Age Limit (General)

- i) **Drivers** (**Post Code No. 45**): Must have attained the age of 22 years and must not have attained the age of 35 years as on 1st July, 2025. However, Telangana Government vide GO Ms No. 30, General Administration (Services-A) Department dated 08-02-2024 have raised the upper age limit prescribed for direct recruitment by 12 (twelve) years to various categories of the Posts to be notified for the purpose of direct recruitment. This relaxation is in addition to the upper age limit as mentioned above.
- ii) **Relaxations in Upper Age Limit:** The Upper age limit prescribed above is however relaxable in the following cases –

Save as provided above, the age limits prescribed can in no case be relaxed.

<u>Note</u>: Name and Date of Birth accepted by the TSLPRB is that entered in the Secondary School Certificate or Matriculation or an equivalent examination certificate. No other document relating to Age like horoscopes, affidavits, birth extracts from Municipal Corporation, Service Records and the like will be accepted.

- **C. Educational Qualification**: Must have passed SSC or its equivalent examination recognized by the State Government as on 1st July 2025.
- **D. Driving Licence:** Must have possessed a valid driving licence for driving Heavy Passenger Motor Vehicle (HPMV) and Heavy Goods Vehicle (HGV) or Transport Vehicle continuously <u>for a period not less than 18 months as on the date of Notification i.e., 17th September 2025.</u>

Note: Persons who are former Members of Defence Service of India may be permitted to count the period for which they have held a Military Heavy Duty Vehicle Licence towards the period prescribed.

- **E. Medical Standards:** The Candidate must be in good health mentally, bodily and free from any defect likely to interfere for efficient performance of his / her duties. The Medical Examination for fitness to the Candidates consist of the following
- 1. General Physical Examination: Persons with disabilities are not eligible
- 2. Vision Test / Standards
 - (i) Distant Vision: Naked Eye 6/6 (ii) Near Vision: J1
 - (iii) Colour Vision: Normal Colour blindness shall be deemed to be a disqualification for this Post
 - (iv) Field of Vision: Normal (v) Fundus: Normal

Note:

- 1) Candidates provisionally selected shall be referred to the District Headquarters Hospital for examination of their Medical Fitness. Candidates who are declared unfit in eye related issues shall be referred to the Sarojini Devi Eye Hospital, Hyderabad based on the recommendation made by the District Headquarters Hospital. Candidates can be referred / examined only once on such recommendations.
- 2) In order to avert getting disappointed at a later stage, Candidates are advised to have themselves medically examined before applying for the examination to ensure that they meet the prescribed Medical Standards.

12B. ELIGIBILITY CONDITIONS FOR SHRAMIKS (POST CODE 46)

- **A. Gender:** Men and Women are eligible for the Post of Shramiks.
- **B. Age Limit (General)**: Must have attained the age of 18 years and must not have attained the age of 30 years as on 1st July, 2025. However, Telangana Government vide GO Ms No. 30, General Administration (Services-A) Department dated 08-02-2024 have raised the upper age limit prescribed for direct recruitment by 12 (twelve) years to the various categories of the Posts to be notified for the purpose of direct recruitment. This relaxation is in addition to the upper age limit as mentioned above.
- iii) **Relaxations in Upper Age Limit:** The Upper age limit prescribed above is however relaxable in the following cases –

Save as provided above, the age limits prescribed can in no case be relaxed.

<u>Note</u>: Name and date of birth accepted by the TSLPRB is that entered in the Secondary School Certificate or Matriculation or an equivalent examination certificate. No other document relating to Age like horoscopes, affidavits, birth extracts from Municipal Corporation, Service Records and the like will be accepted.

- **C. Educational Qualification**: Must have passed ITI in Mechanic (Diesel / Motor Vehicle) or Sheet Metal / MVBB or Fitter or Auto Electrician / Electrician or Painter or Welder or Cutting and Sewing / Upholster or Millwright Mechanic or Centre of Excellence equivalent in respective trade as on 1st July 2025.
- **D. Medical Standards:** The Candidate must be in good health mentally, bodily and free from any defect likely to interfere for efficient performance of his / her duties. The Medical Examination for fitness to the Candidates consist of the following
- 1. General Physical Examination: Persons with disabilities are not eligible

2. Vision Test / Standards

(i) Distant Vision: Naked Eye / One eyed cases can be considered Corrected Eye - 6/24, 6/36 provided the good eye has vision of 6/9 with or without glasses and near vision

(ii) Near Vision: J1 with glasses should be J2 with glasses

(iii) Field of Vision: Normal (iv) Fundus: Normal

Note:

- 1) Candidates provisionally selected shall be referred to the District Headquarters Hospital for examination of their Medical Fitness. Candidates who are declared unfit in eye related issues shall be referred to the Sarojini Devi Eye Hospital, Hyderabad based on the recommendation made by the District Headquarters Hospital. Candidates can be referred / examined only once on such recommendations.
- 2) In order to avert getting disappointed at a later stage, Candidates are advised to have themselves medically examined before applying for the examination to ensure that they meet the prescribed Medical Standards.

13. ELIGIBILITY CONDITIONS (CANDIDATES TO ENSURE THEIR ELIGIBILITY FOR THE POSTS)

Applying Candidates should ensure themselves that they fulfil all the eligibility conditions. Their admission at all the stages of the Test(s) will be purely provisional and shall be subject to satisfying the prescribed eligibility conditions.

Mere issue of Admit Card / Intimation letter to the Candidate will not imply that his / her candidature has been finally cleared by the Board.

TSLPRB will take up verification of eligibility conditions with reference to Original Documents only at an appropriate time.

14A. SELECTION PROCEDURE FOR DRIVERS (POST CODE 45)

<u>Admit Card / Intimation Letter</u>: Candidates who applied for the Post of Drivers will be informed the dates for downloading the Admit Card / Intimation letter through the website www.tgprb.in for appearing in the Physical Measurement Test and Driving

Test along with Certificates Verification with details of Venue, Date and Time. Candidates should bring all the original documents including Driving Licence and two sets of photocopies along with Admit Card / Intimation Letter while attending the Driving Test.

A) Physical Measurement Test: All the eligible registered Candidates shall be required to appear for the Physical Measurement Test and should meet the requirement that **must not be less than 160 Cms in height**.

The Candidates who qualify in the Physical Measurement Test shall have to appear for Certificates Verification on the same day.

B) Driving Test: The Candidates who are found eligible basing on the verification of documents shall be required to appear and qualify in a Driving Test. The Chairman, Telangana State Level Police Recruitment Board will constitute a Committee for conducting this Test with the Officers from Police Transport Organization, Road Transport Corporation and Road Transport Authority.

Candidates must qualify in the Driving Test carrying a maximum of 60 marks in 7 (seven) parameters mentioned below, out of which at least 30 marks must be obtained. If a Candidate secures less than the prescribed minimum marks in three or more parameters he / she would be deemed to have failed in the test even though he /she secures minimum marks i.e., 30 marks in the aggregate.

While filling up the vacancies, the first 5% of the Posts shall be filled following combined Qualified Candidates List (in descending order of marks obtained) of the Candidates and thereafter, the remaining 95% of the Posts shall be filled up by local Candidates of respective districts of contiguous district cadre and as per the ratios basing on the population of the local districts in each contiguous district cadre.
- **F)** Merit among Candidates who secure same Marks: When 2 (two) or more Candidates in a particular category obtain equal marks, then preference will be given to the Candidate who was born earlier.

14B. SELECTION PROCEDURE FOR SHRAMIKS (POST CODE 46)

<u>Intimation Letter / Admit Card</u>: Candidates who applied for the Post of Shramik will be informed the dates for downloading the Admit Card / Intimation letter through the website www.tgprb.in for appearing to the Certificates Verification with details of Venue, Date and Time. Candidates should bring all the original documents and two sets of photocopies along with Admit Card / Intimation letter while attending the Certificates Verification.

A) Weightage marks: Candidates who are found eligible based on Certificates Verification shall be awarded 100 marks as Weightage on basis of the Academic Qualifications and Apprenticeship Certificate by NAC, as specified below

- **B) Minimum Qualifying marks:** The minimum qualifying marks is 50% for OCs including EWS, 45% for BCs and 40% for SCs / STs, out of aggregative 100 marks.
- C) Selection: Selection of the Candidates who got minimum qualifying marks shall be made strictly on their relative merit, as obtained by them based on their aggregate score of Weightage Marks i.e., 100 Marks. While filling up the vacancies, the first 5% of the Posts shall be filled following combined Qualified Candidates List (in descending order of marks obtained) of the Candidates and thereafter, the remaining 95% of the Posts shall be filled up by local Candidates of respective districts of contiguous district cadre and as per the ratios basing on the population of the local districts in each contiguous district cadre.
- **D)** Merit among Candidates who secure same Marks: When 2 (two) or more Candidates in a particular category obtain equal marks, then preference will be given to the Candidate who was born earlier.

15. CERTIFICATES VERIFICATION

Candidates have to produce Original documents (along with two sets of photocopies) and other particulars on the day of verification itself for verification or as and when required and called for. If Candidate(s) fails to produce the certificates at the time of verification and the particulars furnished in the Online Application Form do not tally with the Original documents produced by the Candidate(s), the candidature will be rejected / disqualified without any further correspondence.

16. RESERVATION TO LOCAL CANDIDATES

Reservation to Local Candidates is applicable as per the Presidential Order, 2018 which is adapted in Regulation 8 of TGSRTC Recruitment Regulations. Districts within each of Contiguous District Cadre for the Posts is shown in the following table

Candidates claiming Reservation as local Candidates should enclose the required Study Certificate(s) for the duration of education from I class to VII class issued by the Government School Authorities / Government Recognized School Authorities. Within the 7 (seven) years, in case the Candidate did not study in any Government or

Government Recognized School, then, Residence Certificate (for such period) issued by Tahsildar of the concerned Mandal, should be enclosed for determining local status.

Note:

- a) Single Certificate, whether of study or residence would suffice for enabling the Candidate to apply as a "Local Candidate"
- b) Residence Certificate will not be accepted, if a Candidate has studied in any Government or Government Recognized Educational Institution up to 7th class. Such Candidates have to produce Study Certificates only, for such duration, invariably. Candidates, who acquired degree from Open Universities without studying in any School have to submit Residence Certificate/s only.

17. CAPTURE AND AUTHENTICATION OF BIOMETRICS

TSLPRB will take fingerprints and photographs of the Candidates at the time of attending Driving Test / Certificates verification and whenever required.

18. SELECTION TO BE PROVISIONAL

Selection of the Candidates will be provisional and shall be subject to verification of the original certificates, antecedents and medical fitness.

19. INCLUSION IN QUALIFIED CANDIDATES LIST DOES NOT CONFER ANY RIGHTS

Mere admission to any test / examination or inclusion of a Candidate's name in Qualified Candidates List shall not confer on him / her any right for selection / appointment to such service, class or category. The provisional selection of the Candidates to the Posts mentioned in this Notification is subject to several other requirements mentioned herein

20. VERIFICATION OF ANTECEDENTS

As per Regulation 7 of TGSRTC Recruitment Regulations, no person shall be eligible for appointment to any service by direct recruitment unless the Selection Authority and the Appointing Authority are satisfied that his / her character and antecedents are such as to qualify him / her for such service.

21. DISQUALIFICATION FOR SELECTION / APPOINTMENT

Candidates falling under the following categories shall be disqualified for selection / appointment

- a) Suppression of material facts in the Online Application Form / Attestation Form
- b) If he / she himself / herself or through relations or friends or any others has canvassed or endeavored to enlist for his / her candidature extraneous support, whether from official or non-official sources for selection / appointment to any Service
- c) No person who has more than one wife living or who has spouse living, marries in any case, in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for selection / appointment by direct recruitment to any Service.
- d) No woman whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for selection / appointment by direct recruitment to any Service.
- e) No person who has been dismissed from a State or Central Government service or from the service of Central or State Government undertaking or local or other authorities or who has been convicted by a court of law for an offence involving moral turpitude shall be eligible for selection / appointment to any Service.

22. SUPRESSION / WITHHOLDING OF FACTS – NOT ADVISABLE
