NOTIFICATION MODIFICATION TO QUESTIONS/ANSWER KEY, CLAT 2025

The Consortium constituted a Subject Expert Committee to review the objections filed by the UG applicants and another Subject Expert Committee to review the objections filed by the PG applicants. The recommendations of the Subject Expert Committees chaired by Prof. (Dr.) Ishwar Bhatt, Former Vice Chancellor of NUJS and Karnataka State Law University which reviewed the objections to the questions and answer keys received from the candidates, were placed before the Oversight Committee for its decision. The Oversight Committee chaired by Hon'ble Mr. Justice S.R. Bannurmath, Former Chief Justice, High Court of Kerala and Former Chairperson, Maharashtra State Human Rights Commission considered those recommendations and finally recommended the following changes/modifications in the Question Booklets and Answer Keys of UG and PG for CLAT 2025. The Executive Committee of the Consortium of National Law Universities reviewed those recommendations received from the Oversight Committee and approved the changes/modifications recommended by the Oversight Committee.

The Consortium of National Law Universities has constituted a Grievance Redressal Committee under the chairmanship of Hon'ble Mr. Justice G Raghuram, Former Director, National Judicial Academy, to receive and resolve any grievances that candidates may have with respect to the Common Law Admission Test 2025 (CLAT 2025). A separate notification explaining the grievance filing process is uploaded on the website of the Consortium.

MODIFICATION TO QUESTIONS CLAT 2025 UNDERGRADUATE

Four questions in Logical Reasoning Section are withdrawn. Accordingly, the evaluation of candidates for the CLAT 2025 UG shall be out of 116 marks in place of the originally announced 120 marks.
