## Subject: Declaration of Final Result of Combined Hindi Translators Examination, 2024 - regarding.

Result of Paper-I of Combined Hindi Translators Examination, 2024 was declared on 14.02.2025. A total of 2146 candidates were shortlisted in Paper-I for appearing in Paper-II (Descriptive) of the examination. Thereafter, Paper-II of the Examination was conducted on 29.03.2025.

2. As per relevant provisions of the Notice of the said Examination, Document Verification (DV) would be done by the Indenting/ User Departments. Further, as per Para 15 of the Notice of said Examination, Option-cum-preference would be taken online from the candidates before declaration of the final result.

3. Accordingly, as per Important Notice dated 09.06.2025 of the said Examination, Option-cumpreference has been taken online from the candidates from 09.06.2025 to 14.06.2025, who had appeared in Paper-II of the said Examination. A total of 1736 candidates, who had submitted their Option-cum-Preference online, have been considered for further selection process.

4. Allocation of Posts and Departments to the provisionally shortlisted candidates has been made on the basis of the performance of candidates in Paper-I & Paper-II and the preference of Posts/ Departments submitted by them online.

5. Keeping in view the vacancy position, category-wise details of 272 candidates provisionally qualified for appointment to various posts in different Ministry/ Departments/ Offices are as given below:

Resolution of Tie cases: As per provisions in Para 17 of Notice of the said Examination, in cases where more than one candidate has secured the equal aggregate marks in Paper-I + Paper-II, tie has been resolved by applying the following methods one after another in the given order till the tie is resolved:

- i) Total marks in Paper-II.
- ii) Marks in Part (i) of Paper-I (i.e. General Hindi).
- iii) Date of birth, with older candidates placed higher.
- iv) Alphabetical order of the names of the candidates.

9. 01 candidate bearing Roll No. 7204000208 has been debarred by the Commission.

10. Any discrepancy with respect to the selection/ non-selection/ allocation of post/ User Department, etc. may be brought to the notice of the Commission within a period of one month. Any such representation received after one month will not be entertained by the Commission.

11. Post declaration of the final result of the Examination, further process of Document Verification and Appointment formalities will be undertaken by the Allocated Department in respect of the shortlisted candidates. If a candidate does not receive any correspondence from the concerned allocated User Department within a period of six months from the declaration of final result, he/she must communicate immediately with the concerned User Department. The Commission will not, in any circumstances, entertain any correspondences regarding Document Verification/appointment formalities from the shortlisted candidates.

12. No Reserve List/ Waiting List is prepared by the Commission. Unfilled vacancies in the final result and vacancies arising out of non-joining of shortlisted candidates will be carried forward to the subsequent year(s) of recruitment by the concerned Departments/Organisations.
