ADVERTISEMENT

In terms of commitment before the Hon'ble High Court in Item No.1 MAT/483/2025, Item No.2 FMA/697/2025 & Item No.3 FMA/702/2025 on dated 08.08.2025 this detailed advertisement is issued by the Public Service Commission, West Bengal in continuation with earlier indicative advertisement no. 9/2024, dated 07/12/2024. The Commission will hold the **West Bengal Judicial Service Examination, 2024** in accordance with the existing rules for recruitment to the posts in West Bengal Judicial Service. The necessary particulars are stated in the following paragraphs. A candidate should verify from the notified rules that he/she is eligible for admission to the examination. The conditions prescribed cannot be relaxed.

The W.B.J.S. Examination, 2024 will be held in three successive stages, viz., (i) Preliminary Examination (MCQ Type), (ii) Final Examination (Conventional Type – Written) and (iii) Personality Test. A number of candidates to be selected on the results of the Preliminary Examination will be allowed admission to the Final Examination and a number of candidates to be selected on the results of the Final Examination will be called to appear at the Personality Test.

The Preliminary Examination will be held at Kolkata (Code – 11) and Darjeeling (Code – 12) tentatively in February, 2026. Only candidates of Kalimpong District and three Hill Sub-divisions of Darjeeling, viz., Darjeeling Sadar, Mirik and Kurseong will be allowed to appear at Darjeeling Centre. The Final written Examination will be held at Kolkata tentatively in May, 2026 which will be notified by the Commission after the Preliminary Exam. Personality test will be held thereafter in the office of the Public Service Commission, West Bengal, in Kolkata.

RESERVATION	The benefits of reservation of vacancies for S.C/S.T/O.B.C. (Non-Creamy Layer)/EWS candidates are admissible to S.C. /S.T. /O.B.C. (Non-Creamy Layer)/EWS candidates of West Bengal only. The S.C. /S.T. /O.B.C. candidates of other States shall be treated as general candidates. Reservation of vacancies are shown as reported by the Judicial Department. As per Notification No. 1324-J dated 18.04.2024 of Judicial Department, Govt. of West Bengal, <u>persons</u> suffering from Autism, Intellectual Disability and Mental Illness are unsuitable for the post of Civil Judge (Junior Division/Judicial Magistrate).
QUALIFICATIONS	(i) A citizen of India or such a person of other nationality as declared eligible by Government of India; (ii) A degree in Law from any University or Institution affiliated to any University recognized by the State Government or the Central Government; (iii) Enrolment as an advocate in the roll of Bar Council of any State or Union Territory in India on the date of advertisement for the examination; (iv) Ability to read, write and speak in Bengali (not required for those candidates whose mother tongue is Nepali) – vide Finance Department's Notification No.1243-F(P) dated 02.03.2016. Such ability will be tested at the

	time of interview. Candidature of the candidates with poor performance in the knowledge of Bengali test shall be liable to be cancelled. AGE	Not less than 23 years and not more than 35 years on the date of advertisement for the examination on 07.12.2024 (i.e.born not earlier than 08.12.1989 and not later than 07.12.2001).
CONCESSION IN AGE	(i) Upper age limit is relaxable by 5 years for SC and ST candidates of West Bengal, by 3 years for OBC (Non Creamy Layer) candidates of West Bengal and upto 45 years of age for Persons with Disabilities having physical disability of 40% and above and by 2 years for candidates who have been in Government service for at least two years. (ii) The claim of a candidate for relaxation of age as a Government employee should be proved by a certificate from the appointing authority showing the period of his/her continuous service under Government and the same should be produced on demand. (iii) Age as recorded only in Madhyamik or equivalent certificate will be accepted.
CHANCE LIMIT	NO CANDIDATE OTHER THAN THE CANDIDATES BELONGING TO SC/ST/OBC (NON-CREAMY LAYER) OF WEST BENGAL SHALL BE ALLOWED TO APPEAR IN THE EXAMINATION FOR MORE THAN THREE TIMES. PROVISIONS REGARDING PwBD CANDIDATES	Candidates having Benchmark Disabilities with limitation in writing including that of speed may be allowed the help of Scribe, if required. For convenience, PwBD candidates are requested to bring their own scribes. The Scribe should possess educational qualification one step below the qualification of the candidates taking examination. The persons with Benchmark Disabilities opting for own scribe should submit details of the scribe as per proforma supplied by the Commission at the time of examination. In case of category of persons with Benchmark Disabilities, the provisions of scribe can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Medical Superintendent of a Government health care institution as per proforma at APPENDIX-I (available at the end of this advertisement). OTHER REQUIREMENTS	(i) The candidate must be - A citizen of India (either natural or by registration), or - Such other nationals as declared eligible by the Govt. of India. Provided that a candidate belonging to category (b) shall be a person in whose favour a certificate of eligibility has been issued by the Government. A candidate in whose case a certificate of eligibility is necessary may be admitted to the examination but the offer of appointment may be given only after the necessary eligibility certificate has been issued to him by the Government. NOTE:

The Judicial Department, Government of West Bengal issued a Notification bearing No.1324-J, dated 18th April, 2024 exempting the persons **suffering from Autism, Intellectual Disability and Mental Illness** from the purview of reservation in terms of proviso to section 33 of the Rights of Persons With Disabilities Act, 2016 (49 of 2016). **The said Notification dated 18th April, 2024 is reproduced below :**

NOTIFICATION

No.1324-J, dated 18th April, 2024 – WHEREAS a person holding the posts of Civil Judge (junior division)/Judicial Magistrate (hereinafter referred to as the said post) in the West Bengal Judicial Service under the Judicial Department, Government of West Bengal, is required to examine several documents and is also required to take into consideration the fact of the cases before making proper adjudication of the litigation after hearing the parties;

AND WHEREAS judicial mind is required to be applied by the judicial officers before any cases are disposed of by them.

AND WHEREAS any commission or omission on the part of the judicial officers, may hinder dispensation of justice to the litigant parties;
NOW, THEREFORE, considering above aspects of the functional domain of the said post and in exercise of the power conferred by section 33 of the Rights of Persons With Disabilities Act, 2016 (49 of 2016) (hereinafter referred to as the said Act), the Governor, in pursuance of the proceedings of the meeting of the Expert Committee held on the 4th day of March, 2024 is pleased hereby to identify the post in the Judicial Department, Government of West Bengal, as mentioned in column (3), to be reserved for the category of persons with benchmark disabilities under the said Act mentioned in column (5), of the Table below.

Note 1.- It may be explained that abbreviations used for functional requirements of posts shall denote as follows:-

S – Sitting, RW = Reading & Writing, C = Communication.

Note 2. – it may further be explained that abbreviations used for Category of Benchmark Disabilities shall denote as follows:-

Note 3.- For removal of doubts, it may also be explained that persons with SD/SI with associated limb dysfunction shall be covered under the respective sub-category such as OA, OL, BA, BL, OAL, BLOA, BLA, as the case may be.

2. This notification shall be valid for a period of three (3) years in accordance with the provision of section 33(iii) of the said Act unless earlier reviewed for ascertaining identified post for persons with benchmark disabilities at a periodic interval.

CAUTION	i. Candidates are advised to read thoroughly and cautiously the "Advertisement" and "Scheme & Syllabus" ii. Application once submitted shall be treated as final. No request for change in application form and no claim for being a member of the EWS, SC, ST, OBC (Non- Creamy Layer) and PwBD community will be entertained after the final submission of application. iii. The candidates must abide by the instructions as may be given by Supervisors / Invigilators of the Examination. SCHEME AND SYLLABUS	Since the Code of Criminal Procedure, The Indian Penal Code & The Evidence Act no longer exist and BNSS, BNS and BSA has come to force with effect from 01-07-2024, the syllabus for Preliminary and Final Examination has been modified by substituting the Code of Criminal Procedure, The Indian Penal Code & The Evidence Act with the Bharatiya Nagarik Surukshya Sanhita (BNSS), the Bharatiya Nyaya Sanhita (BNS) and the Bharatiya Sakshya Adhiniyam (BSA). Necessary amendments in relevant recruitment rule will be notified in due course. However, the change in the syllabus will be implemented in the West Bengal Judicial Service Examination 2024. PENALTY	Penalty for disclosure of identity shall be imposed as per the decisions of the Full Commission, dated 14th January, 2021.
LANGUAGE FOR ANSWERING IN THE MAIN EXAMINATION	Answer in all the papers, compulsory and optional, except the language paper may be written either in English or in Bengali (unless otherwise directed in these rules or in the question papers). NOTE: Candidate shall write their answers to all the questions in only one and the same language in any particular paper.

RESULTS OF THE EXAMINATION	The names of the candidates called to Personality Test and those recommended for appointment will be published provisionally subject to determination of eligibility of the candidates in all respects and verification of original certificates etc. If at any stage of such verification any candidate is found unsuitable, his / her candidature / allotment will be cancelled even after recommendation. The Preliminary Examination is meant to serve as a Screening test only for the purpose of selection of candidates for the Final Examination. The marks obtained by the candidates in the Preliminary Examination will not be counted for the purpose of determining the Final merit list. The Final merit list will be prepared on the basis of total marks obtained in the Final Examination and the Personality Test. There shall be no separate Qualifying marks for any individual paper or for the Personality Test. The Commission shall have discretion to fix qualifying marks in the aggregate.
