Subject: Recruitment for the position of Community Health Officers on contractual basis under National Health Mission through DH & FW Samity.

Sir/Madam,

To streamline and expedite the engagement process and also to get more applications from local qualified candidates, it has been decided that the recruitment of Community Health Officers on contractual basis under National Health Mission, which were previously recruited directly by WBSH&FW Samiti will now be recruited by District Level Selection Committee under District Health & Family Welfare Samiti on behalf of WB SH&FWS.

In view of the above, you are requested to initiate the recruitment process for the above mentioned position against the sanctioned posts for your district as per the approved ToRs and suggestive vacancy list (attached) by following reservation rules. However a physical verification to be made at District level to identify actual vacancy based on the number of actual operational SC / Suswasthya Kendras. Recruitment process should be initiated against the actual vacancies of Community Health Officers

on contractual basis under National Health Mission in the operational SC / Suswasthya Kendras.

It may also to be noted that district wise separate recruitment notice must be issued from your end.

The engagement should be completed within 31st December, 2025 as per approved ToR and the copy of the engagement orders should be sent to this end after completion of the engagement process.

The Selection procedure for the above mentioned recruitment process will be conducted by District Level Selection Committee as notified on 30/12/2022 on behalf of SH&FWS.

- (iii) They must have registration certificate/ provisional certificate issued from West Bengal Nursing Council (WBNC).
- (iv) Upto 40 years of age as on 1st April of the year of publication of notice. Age relaxation as per Government norms
- (v) Proficiency in Bengali/ local language & dialect.
