DRIVERS AND SHRAMIK RECRUITMENT IN TGSRTC CLARIFICATION ON S C COMMUNITY CERTIFICATES

As per the Notification issued on 17th September 2025 for direct recruitment of Drivers and Shramiks in TGSRTC, Online Applications will be received from tomorrow i.e., on 8th October 2025 (8 a m) and till 5 p m on 28th October 2025.

The Commissioner of SC Development Department, Telangana, has already issued instructions on 22-09-2025 to all District Collectors for issue of SC Caste Certificates in the new prescribed formats as per the Telangana Act No. 15 of 2025, dated 14-04 2025, without any deviation, duly mentioning the specific group i.e., Gr-I / Gr-II / Gr-III.

Candidates of SC Community are advised to obtain their Community Certificates in the new prescribed format (appended to this Press Note) from Tahsildars / Mee Seva Centres and upload the same along with the Online Application. In case, the Candidates are unable to get the new Certificate within time, they may upload the available SC Community Certificate issued by the Competent Authorities of Telangana clearly mentioning the Caste name to avoid delay. However, such Candidates should submit the SC Community Certificate in the new proforma with sub-classification of specific group i.e., Gr-I / Gr-II / Gr-III at the time of Certificates Verification – failing which, Candidature of such Candidate will not be considered under SC Category.
