S and N are immediate neighbours, but both S and N doesn't face south. S is not an immediate neighbour of E and A. J is opposite to X who doesn't sit in row 2. The number of persons sit between J and K is two less than the number of persons sit to the right of P. P doesn't face south. Y doesn't face C. H doesn't face north.

For most Africans, air travel remains a fairytown fantasy—enchanting in theory, but **unreachable** in practice. Despite the continent's growing population of over 1.4 billion, less than 2% of Africans fly regularly. A mix of protectionist policies, poor infrastructure, and high costs has made air travel a luxury enjoyed by only the elite few.

Intra-African flights are among the most expensive globally. A round-trip ticket between Lagos and Nairobi—two key African cities—can exceed \$2000, often more than the cost of flying to Europe. This exorbitant pricing **begets** from excessive fuel surcharges, airport taxes, and a chronic lack of competition. Many African governments have long banned foreign airlines from operating domestic or inter-country routes. While intended to protect national carriers, this **fortress mentality** has produced the opposite effect: weak airlines, limited **connectivity**, and high fares.

This inward-looking approach has had bizarre consequences. It is not uncommon for African passengers to transit through Paris, Istanbul, or Dubai just to reach a neighboring country. The system is illogical and inefficient. While the Yamoussoukro Decision (1999) and its successor, the Single African Air Transport Market (SAATM), aimed to reform the sector, implementation has been sluggish. Only a handful of countries have put these liberalization policies into action.

The lack of reform causes stagnation. Without open skies, real competition cannot emerge. Without competition, prices remain high. And without affordable air travel, continental trade and integration suffer. In contrast, **facilitates** not only the movement of people but the flow of goods, ideas, and economic growth.

African aviation never truly **got off the ground**. To change this, leaders must prioritize regional cooperation, deregulation, and accessibility over isolation and control. Unless bold reforms are enacted, African skies will remain grounded in fantasy—a fairytown spectacle that benefits the few while excluding the many.

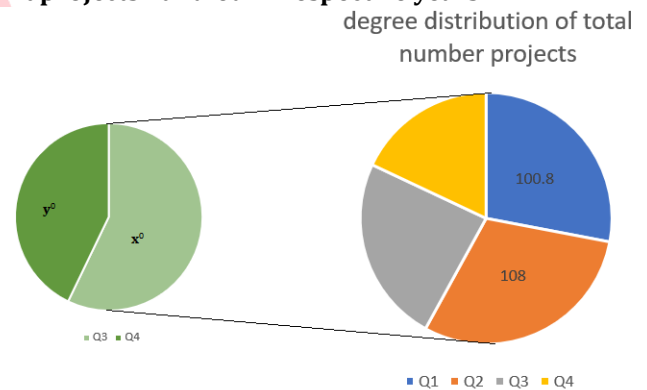

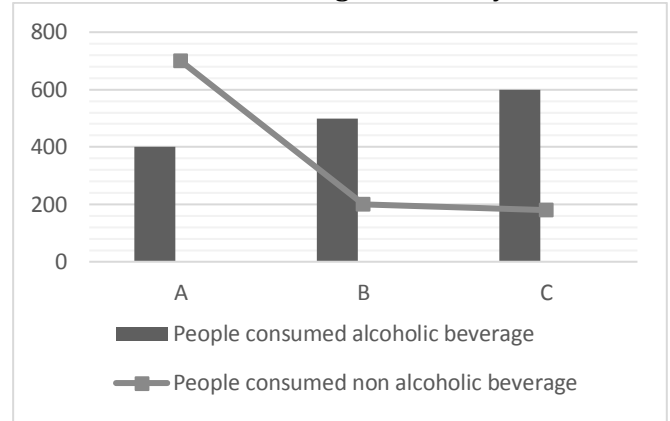

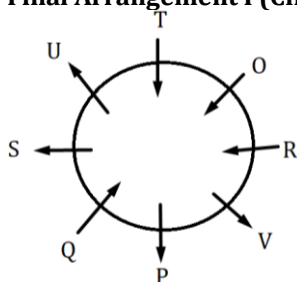

 - **(b)** Exposure to violent content *diminishes empathy* and *fosters irritability*, not the opposite.
 - **(c)** Excessive gaming causes students to *neglect responsibilities* and lose time-management control.
 - **(d)** Academic performance *deteriorates* when gaming becomes excessive, so motivation doesn't remain stable.
- Thus, **only option (e)** is consistent with the author's viewpoint.

- **Incorrect.** The passage states the opposite — that excessive gaming *leads to neglect of academic and social interactions* and even *social alienation*, not increased interpersonal participation.

Conclusion:

Hence, only **(I)** and **(II)** can be logically inferred from the passage.

- **(e)** Mentioned — "*helping students alleviate stress and rejuvenate their minds*" = reduction of psychological strain and cognitive refreshment.

However:

- **(d)** The passage states the *opposite*:
