#### 1. VACANCIES

The Telangana State Level Police Recruitment Board (TSLPRB) invites Applications from eligible Candidates through **ONLINE** mode only in the prescribed proforma which will be made available on TSLPRB Website (<a href="www.tgprb.in">www.tgprb.in</a>) **from 8 a m on 30<sup>th</sup> December 2025 onwards till 5 p m on 20<sup>th</sup> January 2026** for Direct Recruitment to the following Posts in Telangana State Road Transport Corporation (TGSRTC). #### 2. CANDIDATES TO CHECK THEIR ELIGIBILITY BEFORE APPLYING

Candidates who are desirous and eligible <u>REPEAT eligible only</u> may apply through ONLINE mode only after having satisfied themselves of their eligibility for this recruitment (Please see *Para 11: Candidates to ensure their eligibility and Para 4: General Instructions*).

#### 4. GENERAL INSTRUCTIONS

- a. Candidates are required to go through the Notification meticulously and decide themselves as to their eligibility with reference to the laid down criteria for this recruitment carefully, before applying and filling in all the relevant columns in the Online Application Form.
- b. Applications received online shall only be considered and the Telangana State Level Police Recruitment Board (TSLPRB) will not be responsible for any kind of discrepancy.
- c. TSLPRB will not be responsible for any inconsistencies or errors in the Application submitted online. Candidates are advised to strictly follow the instructions in their own interest and to verify the contents before submitting the Online Application Form.
- d. Particulars furnished by the Candidates in the Online Application Form will be taken as final. Candidates should therefore, be very careful in uploading / submitting the Online Application Form.
- e. No relevant column of the Online Application Form should be left blank. Incomplete / Incorrect Online Application Form will be summarily rejected. Information, if any, furnished by the Candidate subsequently in any form will not be entertained by the TSLPRB under any circumstances. Candidates should be careful in filling-up the Online Application Form before submission. If any lapse is detected at any stage of the recruitment process, the candidature will be rejected.
- f. Candidates should not furnish any particulars that are false, tampered or fabricated. They shall not suppress or conceal any material information while filling the Application Form online. In case, if it is found at a later date that any false information has been provided, punitive action will be taken as per law.
- g. Candidates are expected to behave in an orderly and disciplined manner while appearing for the Examinations. Any impersonation will be viewed adversely and such Candidates shall be criminally prosecuted besides being disqualified.
- h. All the testimonials issued by the competent authorities shall compulsorily be produced as and when required. If the Candidate fails to produce the same, his / her candidature will be rejected / disqualified without any further correspondence.
- i. The claim of the Candidates with regard to the Age, Date of Birth, Educational Qualifications, Community etc., are accepted only provisionally based on the information furnished by them in their Online Application Form and Certificates produced, subject to verification and satisfaction of the TSLPRB, at an appropriate

time. Mere acceptance of application, admission to any Exam or inclusion of a Candidate in a Qualified Candidates List does not confer any right for selection. The candidature is therefore, provisional at all stages and the TSLPRB reserves the right to reject his / her candidature at any stage of the selection without giving any notice.

- j. If Candidates who are Under-Aged or Over-Aged apply for this Recruitment Notification, their candidature will be rejected at any time and TSLPRB is not responsible for the same. Fee once paid will not be refunded.
- k. As candidature for the recruitment is processed through Computer / Electronic devices, based on the particulars furnished in the Online Application Form, the Candidates are advised to fill in all the relevant particulars carefully.

#### 5. FEE STRUCTURE

#### 6. PAYMENT OF FEE

<u>I Step</u>: Candidate has to register on the TSLPRB Website – <u>www.tgprb.in</u> by making his / her Mobile Number as his / her User ID. Candidates are advised to provide only such Mobile Number as their Login ID which will be in currency throughout the process of recruitment and will be in their personal custody. It shall be their responsibility to ensure that this number is maintained continuously without any interruption throughout the process of recruitment, so that there will not be any loss of communication between the Board and the Candidates.

<u>II Step</u>: The fee can be paid by using Credit Card, Debit Card, Net Banking or any other mode to be made available on the TSLPRB Website.

**III Step:** After making the Payment, it shall be the responsibility of the Candidate to visit the website <a href="www.tgprb.in">www.tgprb.in</a> to submit the Online Application Form along with a scanned copy of Passport Size Photo + specimen Signature combined as one file / image in jpg format. <a href="Even after making payment of Fee, if the Candidate fails to press submit button">www.tgprb.in</a> to submit be payment of Fee, if the Candidate fails to press submit button and the Application is not uploaded, such Applications shall be rejected without giving any notice and fee once paid will not be refunded in any case.

#### 7. INSTRUCTIONS FOR FILLING THE ONLINE APPLICATION FORM

- a) Candidates are requested to check their eligibility carefully and fill-in all the relevant columns in the Online Application Form. <u>Candidates should not register more than one Application Form for the present Recruitment Process</u>. Submission of more than one application for this recruitment will lead to cancellation of all such Applications.
- b) The steps given below have to be followed by the Candidates who intend to submit the Online Application Form through Payment Gateway
  - i. Registration using Mobile Phone as User ID
  - ii. Select the Post(s) for which he / she wants to apply as per the eligibility
  - iii. Note the Fee that has to be paid depending on the Post/s chosen
  - iv. Payment of Fee using any mode made available
  - v. Continue on TSLPRB Website with the User ID and fill the Application Form
  - vi. Scan and Upload copy of Passport Photograph and Specimen Signature as one file
  - vii. Submit the Application Form
- c) Candidates should keep ready a soft copy of his / her passport size photo + specimen signature combined as one file image in jpg format as shown below to be scanned and uploaded with the Online Application Form.

- d) Application will be rejected, if the Candidate uploads only Photo without Signature. Size of the above image / file should not exceed 100kb (Minimum size is 30 kb). Please note that if the file is not in jpg format, system will reject the same and Candidate may not be able to complete the process of filling up the remaining details of the Online Application Form.
- e) After payment of Fee, Candidates can use the "Apply Online" in the main menu option in the website (www.tgprb.in) to fill his / her Online Application Form.
- f) Candidates are advised to fill their Online Application Form themselves instead of handing it over to others to avoid any wrong entries. <u>If their Online Application Form</u> is being filled by some other person the Candidate should personally be available and

- ensure that the entries are made correctly and Online Application is uploaded successfully.
- g) Candidates are advised to carefully read all the instructions and understand before clicking on "I AGREE".
- h) Candidates should endorse the declaration at the end of the Online Application signifying the fact that they have read and understood all the Rules and Regulations and that they agree to scrupulously abide by them and confirm with an OTP (One Time Password) sent to the Candidate's Registered Mobile.
- i) Once the Candidate submits the Online Application Form, no corrections can be made. Hence, Candidates are requested to carefully verify the details before submission.
- j) After submission of Online Application Form, the Candidate must download a copy of his / her submitted form in Pdf for future use.
- k) Giving false information and Suppression or Concealment of facts will result in disqualification of the Candidates and renders them liable for prosecution.
- Candidature is provisional at all stages. Mere issuance of Hall Ticket to the Candidates will not imply that Candidature has been finally cleared by the TSLPRB. TSLPRB will take up the Verification of Eligibility Conditions with reference to their Original documents, at a later stage before finalizing the Selection after the Candidate is finally qualified.

#### 8. UPLOADING / SUBMISSION OF DOCUMENTS

Copies of the following documents must be uploaded in support of the information given in the Online Application Form where necessary as well as the documents in original should be produced at the time of Certificates verification. Failure to upload the same will lead to rejection of the Application Form.

- i. SSC / Matriculation Certificate or its equivalent in support of Date of Birth
- ii. Educational Qualification Certificates pertaining to the relevant Post/s as per their eligibility (See Para No. 11 (C) of this Notification)
- iii. Study Certificate(s) issued by the Government School Authorities / Government recognized School Authority (from 1<sup>st</sup> to 7<sup>th</sup> classes) or Residence Certificate issued by M R O (in case where the Candidate has not studied in any educational institution) for last 4 / 7 years stay prior to and inclusive of 7<sup>th</sup> Class (Annexure III or IV).

- iv. Latest Community Certificate issued by the competent authority of Government of Telangana. Candidates who belong to SC Category should submit Community Certificate as per Act No. 15 of 2025, dated 14.04.2025 issued by Telangana Government with regard to sub-classification of reservations to SCs
- v. Non Creamy Layer Certificate issued by the competent authority issued on or after 1<sup>st</sup> April 2025 (in case of BC Candidates)
- vi. Certificate of Economically Weaker Section (EWS) category issued by the competent authorities issued on or after 1<sup>st</sup> April 2025 wherever applicable
- vii. PPO (Pension Payment Order) / Discharge Book of Indian Army / Indian Navy / Indian Air Force wherever applicable (For Ex-servicemen)
- viii. Service Certificate by those Employees / Candidates who are working in Telangana State Road Transport Corporation issued by the concerned Authority of TGSRTC for claiming reservation under Departmental Vacancies for the Post/s applied for (Annexure V).

#### 9. RULES GOVERNING THE POST(S)

Telangana State Road Transport Corporation is a Public Sector Undertaking and the recruitment to the Posts of Traffic Supervisor Trainee and Mechanical Supervisor Trainee is being made as per the Regulations / Circulars / Standing Orders / Guidelines issued by TGSRTC from time to time.

#### 10. SPECIAL REPRESENTATION (RESERVATION)

#### A) Reservation

- i) The Rule of Special Representation (Reservation) in terms of Rule 22 and 22 (A) of Telangana State & Subordinate Service Rules, 1996, which is adapted by TGSRTC, shall be applicable.
- ii) Employees of TGSRTC who are in possession of prescribed qualifications and have completed 5 years of service on regular basis being an approved probationer as on the date of Notification i.e., 25<sup>th</sup> December 2025 are eligible for the Posts notified under Departmental Candidates.

#### **B)** Community

i) SC and ST Candidates, who are local Candidates to Telangana as per the Regulation 8 of TGSRTC Recruitment Regulations, are required to produce latest Community Certificate issued by the Competent Authority of Government of Telangana for claiming Age relaxation/reservation. Candidates who belong to SC Category should

submit Community Certificate as per Act No. 15 of 2025, dated 14.04.2025 issued by the Government of Telangana with regard to reservations to SCs by way of subclassification in the State. The SC Community Certificates issued before 14th April 2025 without SC Sub-Classification as per above Act shall not be considered for reservation under SC Category.

- ii) BC Candidates who are local Candidates to Telangana State as per Regulation 8 of TGSRTC Recruitment Regulations, are required to produce Community Certificate (BC-A, BC-B, BC-C, BC-D or BC-E) from Competent Authority of the Telangana State Government.
- iii) Candidates belonging to Backward Classes shall submit the latest Community Certificate to claim age relaxation and the latest Certificate of Non-Creamy Layer issued by the Competent Authorities of Telangana State on or after 1<sup>st</sup> April 2025 to claim Reservation. In case of failure to produce the Non-Creamy Layer Certificate on the day of Certificates Verification such Candidates, will be considered under "Open Competition", if otherwise eligible, and the status cannot be changed later.
- iv) Relaxation in upper age limit and / or reservation to BC-E Group will be subject to the adjudication of the litigation before the Honourable Courts including final orders in Civil Appeal No(s) 2628-2637 of 2010 in SLP No.7388-97 of 2010 dated 25-03-2010 and orders issued, if any, by the Government from time to time.
- v) BC, SC and ST Candidates who are not local to Telangana as per Regulation 8 of TGSRTC Recruitment Regulations, are not entitled for any kind of reservation.

#### C) Economically Weaker Sections (EWS)

Candidates who are local Candidates to Telangana State as per the Regulation 8 of TGSRTC Recruitment Regulations and belonging to Economically Weaker Section category (as per GO Ms No. 65, GA (Ser. D) Department, dated 19.03.2021 r/w GO Ms No. 244, GA (Ser. D) Department, dated 24-08-2021) shall submit the Income and Asset Certificate issued by any of the following Authorities of Government of Telangana State to claim Age relaxation and Reservation under this Category.

- i) District Magistrate / Additional District Magistrate / Collector / Sub-divisional Magistrate / Mandal Revenue Officer
- ii) Revenue Officer not below the rank of Tahsildar and
- iii) Sub-Divisional Officer of the area where the Candidate and / or his family normally resides

#### **D)** Women Reservation

331/3% of the vacancies in each category are reserved for Women under Direct Recruitment on horizontal basis as per GO Ms No. 35, GA (Ser.D) Department, dated 13-02-2024 which is adapted by TGSRTC. Reservation for Women will be a horizontal reservation following the principle of sufficiency i.e., reservation of Women Candidates shall be adjusted proportionately in the respective category to which the Woman Candidate belongs. In the event of non-availability of eligible and suitable Women Candidates, the vacancies reserved for them shall not be carried forward for the succeeding recruitment and shall be filled up by Men Candidates of respective Community Category in the same recruitment.

#### 11. CANDIDATES TO ENSURE THEIR ELIGIBILITY

Candidates applying for the Posts should ensure by themselves that they fulfil all the eligibility conditions for admission to the Written Examination. Their admission at all the stages of the Examination(s) will be purely provisional and shall be subject to satisfying the prescribed eligibility conditions. Mere issue of Hall Ticket to the Candidate will not imply that his / her candidature has been finally cleared by the Board. TSLPRB will take up verification of eligibility conditions with reference to Original Documents only at an appropriate time.

#### A. Eligibility by Gender

Men and Women are eligible for the Posts of Traffic Supervisor Trainee and Mechanical Supervisor Trainee.

#### **B.** Age Limit (General)

i) Must have attained the age of 18 years and must not have attained the age of 25 years as on 1<sup>st</sup> July, 2025. However, the Government of Telangana vide GO Ms No. 30, General Administration (Services-A) Department dated 08-02-2024 have raised the upper age limit prescribed for direct recruitment by 12 (twelve) years to the various categories of the Posts to be notified for the purpose of direct recruitment. This relaxation is in addition to the upper age limit as mentioned above.

ii) **Relaxations in Upper Age Limit:** The Upper age limit prescribed above is however relaxable in the following cases –

- iii) **Departmental Employees:** For Departmental (TGSRTC in-service) Candidates appointed on regular basis, the upper age limit will be reckoned as follows
  - a) Employees belonging to SC / ST / BC categories are given age relaxation to the extent of service rendered in the Corporation on regular basis as on date of Notification i.e., 25<sup>th</sup> December 2025, for the purpose of maximum age limit prescribed for the Post, subject to the condition that on allowing all the applicable concessions the age of the employee should not exceed 45 years as on 1<sup>st</sup> July 2025.
  - b) Employees other than those of SC / ST / BC categories are given age relaxation up to a maximum of 10 years regular service rendered in the Corporation as on date of Notification i.e., 25<sup>th</sup> December 2025, for the purpose of maximum age limit prescribed for the Post, subject to the condition that on allowing all the applicable concessions, the age of the employee should not exceed 40 years as on 1<sup>st</sup> July 2025.

#### Save as provided above, the age limits prescribed can in no case be relaxed.

<u>Note</u>: Name and Date of Birth accepted by the TSLPRB is that entered in the Secondary School Certificate or Matriculation or an equivalent examination certificate. No other document relating to Age like horoscopes, affidavits, birth extracts from Municipal Corporation, Service Records and the like will be accepted

#### C. Educational Qualification

i) **For Post Code No. 47:** Must possess a Graduate Degree awarded by any university in India, established or incorporated by or under a Central Act, Provisional Act of State or of any Institution recognized by the University Grants Commission or any other equivalent qualification as on 1<sup>st</sup> July 2025.

<u>Note:</u> Candidates who possess higher qualification than the prescribed one will also be considered on par with the Candidates who possess the prescribed qualification.

- ii) **For Post Code No. 48:** Must have passed Diploma in Automobile / Mechanical Engineering conducted by the Department of Technical Education, Government of Telangana or its equivalent qualification in the same discipline as on 1<sup>st</sup> July 2025. Candidates possessing higher qualification of BE / B Tech / AMIE in the discipline of Automobile / Mechanical Engineering are also eligible.
- **D. Medical Standards:** The Candidate must be in good health mentally, bodily and free from any defect likely to interfere for efficient performance of his / her duties. <u>Persons</u> with disabilities are not eligible for the notified Posts. The Medical Examination for fitness to the Candidates consist of the following —
- 1. General Physical Examination
- 2. Vision Test / Standards
  - (i) Distant Vision: Naked Eye vision 6/24 in each eye provided the corrected

vision is 6/9 with glasses in each eye

- (ii) Near Vision: J1 with Glasses
- (iii) Colour Vision: Normal. Colour blindness shall be deemed to be a

disqualification for these Posts.

- (iv) Field of Vision: Normal
- (v) Fundus: Normal

#### Note:

- 1) Candidates provisionally selected shall be referred to the District Headquarters Hospital for examination of their Medical Fitness. Candidates who are declared unfit in eye related issues will be referred to the Sarojini Devi Eye Hospital, Hyderabad based on the recommendation made by the District Headquarters Hospital. Candidates can be referred / examined only once on such recommendations.
- 2) In order to avert getting disappointed at a later stage, Candidates are advised to have themselves medically examined before applying for the examination to ensure that they meet the prescribed Medical Standards.

#### 12. SELECTION PROCEDURE / SCHEME

The selection procedure / scheme of Exam will be as follows –

**A)** Written Examination: All the eligible registered Candidates shall be required to appear for the Written Exam in one Paper (three hours duration) for 200 marks (200 Questions - MCQs). Hall Tickets will be issued for this purpose. Subject wise questions for each Post will be as follows –

#### *Note:*

- 1) The minimum marks to be secured by the Candidates in order to qualify in the Written Examination is 40% for Posts under OC including EWS, 35% for Posts reserved for BCs and 30% for Posts reserved for SCs / STs.
- 2) Candidates who secured 40% and above in the Written Examination only are eligible to be considered for selection for Posts under OC/EWS.
- 3) Questions in Written Examination shall be objective in nature and shall be set in English, Telugu and Urdu languages as mentioned above. Candidates have to answer the questions on an OMR answer sheet using Blue / Black Ball Point Pen only. For this purpose, Candidates should bring their own Blue / Black Ball Point Pens along with them to the Examination Hall.
- 4) While evaluating Objective Papers, the marks for the deleted questions, if any, will be awarded to each Candidate proportionately and the marks would be considered up to 3 (three) decimal places, to determine the merit of the Candidate. Thus, with reference to deleted questions, each Candidate will be compensated in proportion to his / her percentage of marks obtained in the rest of the questions (which remain undeleted).
- 5) For each question, the Candidate shall be awarded one mark, if he / she darkened only one bubble that corresponds to the correct answer.
- 6) Mere securing of minimum qualifying marks does not vest any right in a Candidate to be considered for selection.

**B)** Selection: Selection of the Candidates for each Post shall be made strictly on their relative merit, as obtained by them based on their score in the Written Examination (200 Marks). While filling up the notified vacancies in the Zones of Contiguous Zone Cadre, the first 5% of the Posts shall be filled following combined Qualified Candidates List (in descending order of marks obtained) of the Candidates and thereafter, the remaining 95% of the Posts shall be filled up by local Candidates of respective Zones.

C) Merit among Candidates who secure same Marks: When 2 (two) or more Candidates in a particular category obtain equal marks, preference will be given to the Candidate who was born earlier.

#### 13. INSTRUCTIONS TO BE READ CAREFULLY

The requisite Educational Qualification, Age and Procedure to be followed for selection etc., are given in this Notification. Candidates must read the instructions given in this Notification carefully in their own interest.

#### 14. CERTIFICATES VERIFICATION

Candidates have to produce Original Documents (along with two sets of photocopies) and other particulars on the day of verification itself for verification or as and when required and called for. If Candidate(s) fails to produce the Certificates at the time of verification or if the particulars furnished in the Online Application Form do not tally with the Original Documents produced by the Candidate(s), the candidature will be rejected / disqualified without any further correspondence.

#### 15. RESERVATION TO LOCAL CANDIDATES

Reservation to Local Candidates is applicable as per the Presidential Order, 2018 which is adapted in Regulation 8 of TGSRTC Recruitment Regulations. Zones within each of Contiguous Zone Cadre for the Posts is shown in the following Table –

Candidates claiming Reservation as Local Candidates should enclose the required Study Certificate(s) for the duration of education from I class to VII class issued by the Government School Authorities / Government Recognized School Authorities. Within the 7 (seven) years, in case the Candidate did not study in any Government or Government Recognized School, then, Residence Certificate (for such period) issued by Tahsildar of the concerned Mandal, should be enclosed for determining local status.

#### Note:

- a) Single Certificate, whether of study or residence would suffice for enabling the Candidate to apply as a "Local Candidate"
- b) Residence Certificate will not be accepted, if a Candidate has studied in any Government or Government Recognized Educational Institution up to 7<sup>th</sup> class. Such Candidates have to produce Study Certificates only, for such duration, invariably. Candidates, who acquired Degree from Open Universities without studying in any School have to submit Residence Certificate/s only

#### 16. CAPTURE AND AUTHENTICATION OF BIOMETRICS

TSLPRB will take fingerprints and photographs of the Candidates at the time of attending Written Examination and whenever required.

#### 17. SELECTION TO BE PROVISIONAL

Selection of the Candidates will be provisional and shall be subject to verification of the original certificates, antecedents and medical fitness. Mere admission to any test /

examination or inclusion of a Candidate's name in Qualified Candidates List shall not confer on him / her any right for selection / appointment to such service, class or category. The provisional selection of the Candidates to the Posts mentioned in this Notification is subject to several other requirements mentioned herein.

#### 18. VERIFICATION OF ANTECEDENTS

As per the Regulation 7 of TGSRTC Recruitment Regulations, no person shall be eligible for appointment to any service by direct recruitment unless the Selection Authority and the Appointing Authority are satisfied that his / her character and antecedents are such as to qualify him / her for such service.

#### 19. DISQUALIFICATION FOR SELECTION / APPOINTMENT

Candidates falling under the following categories shall be disqualified for selection / appointment.

- a) Suppression of material facts in the Online Application Form/Attestation Form
- b) If he / she himself / herself or through relations or friends or any others has canvassed or endeavoured to enlist for his / her candidature extraneous support, whether from official or non-official sources for selection / appointment to any Service
- c) No person who has more than one wife living or who has spouse living, marries in any case, in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for selection / appointment by direct recruitment to any Service.
- d) No woman whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for selection / appointment by direct recruitment to any Service.
- e) No person who has been dismissed from a State or Central Government service or from the service of Central or State Government Undertaking or local or other authorities or who has been convicted by a court of law for an offence involving moral turpitude shall be eligible for selection / appointment to any Service.

#### 20. SUPRESSION / WITHHOLDING OF FACTS – NOT ADVISABLE

Suppression of material facts or withholding any factual information in the Application or Attestation Form (which would be supplied to the Candidates who are declared provisionally selected) will disqualify the Candidate from being considered for appointment.

#### 21. DISCHARGE FROM SERVICE AFTER APPOINTMENT

In the event of any information being found false or incorrect or if ineligibility is detected at any time even after appointment, such Candidate shall be discharged from service forthwith by the Appointing Authority without giving any notice.

#### 22. TRAINING AND STIPEND ALLOWANCE

The selected Candidates shall undergo Training for a period of 12 months. During the period of training (regular as well as extended period), Candidates for the Post of Traffic Supervisor Trainee / Mechanic Supervisor Trainee shall be eligible for stipend i.e., minimum of the time scale of Deputy Superintendent (Traffic) / Deputy Superintendent (Mechanic). On successful completion of training, they will be appointed in the regular Post as Deputy Superintendent (Traffic) / Deputy Superintendent (Mechanic).

#### 23. INDEMNITY BOND

Provisionally selected Candidates who are found medically fit and whose certificates / antecedents are genuine have to execute an Indemnity Bond before their appointment as Traffic Supervisor Trainee / Mechanical Supervisor Trainee to serve the Corporation, up to 5 years after Training.
