candidate must have attained the age of 21 years and must not be above the age of 42 years as on the **1<sup>st</sup> day of January 2026**. The upper age limit is relax-able by 05 (five) years for candidates belonging to SC /ST / SEBC / Women / Ex-Serviceman and by 10 (ten) years for PWDs whose permanent disability is 40% or more. Persons with disabilities belonging to SC / ST /SEBC categories are eligible for cumulative age relaxation benefit. The age relaxation for SPC Board's, Odisha, internal candidates will be the number of years put by the candidates in their respective posts. In the case of a candidate who is or was holding a post under the State or Central Government or Local Authority or Corporation established by a State Act or a Central Act or established by the Government under a State Act or Central Act and owned or controlled by the Government, by the number of years during which he is or was holding such post or five year whichever is less;

In the event of non-availability of sufficient number of eligible women candidates belonging to any particular category, the vacancies or the remaining vacancies will be filled up by the male candidates of that category
