

Qualification and experience	: Candidates with a Master's degree in Statistics, with experience using SPSS and/or R; MCA/ M.Sc. Data Science with knowledge of Web based portal/ Database Management.
Pay	: A consolidated pay of ₹30000/- (Rupees thirty thousand only) per month.
Tenure of Appointment	: The duration of appointment is from <b>01 April 2026 to 31 March 2027</b> which may be extended later/ terminated earlier, depending on availability of funds and performance of the candidate.
