The candidates are being qualified to the Final examination provisionally subject to verification of their eligibility and suitability for the examination in all respects including verification of documents (e.g. Proof of Age, Academic Qualification, caste, PwBD status, EWS status etc.) at the stage of Personality Test, if qualified for the same. If a candidate fails to produce any of the required original certificate(s) for verification before Personality Test he/she will not be interviewed by the Commission and his/her candidature will be liable to be cancelled by the Commission straightway.
3. If at any stage even after issue of the letter of appointment, a candidate is found ineligible in terms of Advertisement, his/her candidature will be cancelled without further reference to him/her.
