**Peon/Orderly/Dak Peon under Post Code 822/24 in District and Sessions
Courts/Family Courts**

1. The DSSSB vide its vacancy notice/Advertisement No. 08/24 dated 12/03/2024 had advertised **99 vacancies [UR-43, OBC-29, SC-08, ST-09, EWS-10 including ESM-25, PwBD {Cat(a)-02, Cat(b)-01 & Cat(d&e)-04}]** for the post of Peon/Orderly/Dak Peon under post code 822/24 in District and Sessions Courts/Family Courts.
2. As per examination scheme, the online Objective Test (MCQ) of 100 Marks was conducted by DSSSB on 09.11.2025, 11.11.2025, 15.11.2025 to 23.11.2025, 29.11.2025, 06.12.2025 & 07.12.2025 (Total 14 days) wherein 24077 candidates appeared.
3. The normalized marks obtained by 24077 candidates who appeared in the CBT Objective (MCQ) exam have been uploaded on Board's website. Candidates can view their marks by logging in to their account in OARS module on www.dssbonline.nic.in.
4. The candidates who scored 50% for General Category i.e. 50 Marks and 45% for Reserved Category i.e. 45 Marks in the Objective/MCQ Test has been shortlisted for interview. Interview of 15 marks will be conducted by O/o Ld. Principal District & Sessions Judge (HQs). The final selection of candidates will be on the basis of marks secured in objective/MCQ examination and interview.
5. Based on the performance in CBT Objective (MCQ) for the post of Peon/Orderly/Dak Peon under post code 822/24 in District and Sessions Courts/Family Courts, the category wise details of shortlisted candidates are as follows:

6. Only those candidates have been considered in OBC category who has declared in their online application form that they have obtained OBC (Delhi) Caste Certificate. Reserve category candidates who obtained marks above or equal to the last shortlisted UR category candidate in CBT Objective (MCQs) have only been shortlisted against UR vacancies for Interview otherwise they are shortlisted in their respective category.
7. The above shortlisting of candidates for Interview for the post of Peon/Orderly/Dak Peon under post code 822/24 in District and Sessions Courts/Family Courts will be subject to outcome of pending court cases, if any.
8. Since the documents have not called from the candidates along with application forms as such details scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of

- name in the list of candidates shortlisted for interview does not entitle them any right over the post.
9. The candidates shortlisted for interview for the post of Peon/Orderly/Dak Peon under post code 822/24 in District and Sessions Courts/Family Courts are hereby informed that **the further process of Interview will be conducted by O/o Ld. Principal District & Sessions Judge (HQs) and the final selection of candidates will be on the basis of final merit list prepared by the O/o Ld. Principal District & Sessions Judge (HQs) itself on basis of marks secured in both objective/MCQ examination and interview.**
 10. Further, the DSSSB will not, in any circumstances, entertain any correspondences regarding Interview etc from the candidates.
 11. While every care has been taken in preparing the list of shortlisted candidates for interview, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
