**Counselling for choice of Post/District for the posts of RI, ICDS Supervisor, ARI, Amin & SFS under CRE-2023(IV)**

In continuation to Notice No. 2640/OSSSC dt.28.08.2026, the Commission have been pleased to decide that counselling for choice of Post and District for recruitment to the district cadre posts of **RI, ICDS Supervisor, ARI, Amin & SFS under CRE-2023(IV)** will further continue from **8<sup>th</sup> September, 2026 onwards** in the office of Odisha Sub-ordinate Staff Selection Commission, Bhubaneswar. The candidates are called for counselling strictly in order of merit to choose their Post and District. The Roll Nos. of candidates provisionally allowed to participate in the counselling are published date wise as **Annexure-III to VI**. Subsequent Counselling dates will be notified later.

However, the candidature of all the candidates as published herewith is purely provisional and subject to final verification at Commission's level.

**N.B. -** Some candidates more than the number of category wise vacancies advertised have been called for counselling. They will get chance to participate in the counselling process if any of the selected candidates higher in the Provisional Merit List fail to attend the counselling process or forgo the present allocation or are found ineligible for these posts.

The candidates are required to follow the instructions of counselling as given below.

1. The candidates must attend the counselling on the date, time and venue fixed and wait till their turn comes. **They must come with the Intimation Letter along with original and photocopy of Adhaar card/Voter ID card/any other Government Identity Proof, Educational Certificates, Marksheets and other documents.**
2. Those who are unable to come for the counselling on the date and time fixed may send their authorized representative with Authorization Letter. The representative shall come with his/her Adhaar card/Voter ID card/any other Government Identity Proof along with the candidate's all documents **as mentioned at Point No. 1 above.** (Sample authorization letter is given at Appendix-I).

3. Latecomers shall lose the opportunity of exercising their choice for the post and district. He / she may be allowed to exercise his/ her choice for the post and district available at that point of time. Since counselling will start at the scheduled time, latecomers will be deprived of exercising their right of choice to that extent.
4. No request for consideration shall be allowed if the candidate or his/her authorized representative, as the case may be, remains absent during the entire counselling process.
5. No request for extension of time for counselling shall be allowed under any circumstances.
6. The candidates/their representatives are required to exercise their choice for the post and district on the spot considering the vacancy position as available at that point of time with respect to the Annexure- I to V of the Advertisement. No further request for change of choice for post/district shall be allowed, thereafter.
7. The decision of the Commission regarding allocation of Post and District shall be final.

Intimation Letters for the purpose of counselling have been uploaded in the Commission's web portal. The details of the schedule of counselling and venue are available in the Intimation Letter. The candidates are advised to download the Intimation Letter by logging into the Commission's web portal with their User Id and Password to enable them to participate in the counselling.

**No hard copy of Intimation Letter will be sent to any candidate by post.**

**NOTE:** 1. It is also made clear that candidature of the candidates for this recruitment is purely provisional and is subject to fulfillment of the terms and conditions laid down in the advertisement. The candidature is liable for rejection in the event of inadequacy/deficiency found at any stage even after the selection process is over.

2. Any inadvertent mention of Roll Nos. of any candidate in the Annexures shall not confer any right for claiming participation in the provisional counselling process.

**Mere participation in the counselling process and/or filing of choice of Post and District does not confer any right upon the candidate for appointment.**
