Roy Multi-Speciality Medical Research Centre and a hospital, Dr. Syama Prasad Mookerjee Superspeciality Hospital within its campus at Kharagpur. The upcoming medical college will be equipped with state-of-the-art teaching and research facilities embedding world standard technologies and IT connectivity in providing a stimulating academic environment for faculty members willing to stretch their clinical boundaries. Primary objective of this endeavour is to run MBBS program and to nurture world class translational medical research in a multi-disciplinary environment in collaboration with allied academic units of IIT Kharagpur. The hospital in the first phase has started out-patient service, and the inpatient services with critical care and operation theatre will be functional in second phase.
