The candidate provisionally admitted for verification of certificates is required to produce the Original Certificates relating to Age (SSC), proof of Age Relaxation, Educational Qualification and Technical Qualification as mentioned in the notification, Study Certificate, Integrated Community Certificate in case of reserved candidates, Certificate of exclusion from Creamy Layer in case of BCs obtained from revenue authorities in terms of G.O.Ms.No.3, Backward Classes Welfare (C2) Dept., Dt: 04.04.2006 read with G.O.Ms.No.26, BC Welfare (C) Dept., Dt: 09.12.2013, Migration Certificate for candidates who migrated from Telangana to Andhra Pradesh at the time of verification of Original Certificates, failing which, they will not be treated as eligible with reference to the particulars furnished by him / her in the online application form / Certificates. The results of such candidate (s) shall be cancelled at any stage in the process of selection. The Commission has the right to disqualify any candidate, if he / she is not found eligible for any reason.
