In compliance of the directions of the Hon'ble High Court Delhi dated 27.10.2021 in W.P.(C) No. 9040/2019 read with CM No. 22861/2020 & CM No. 25471/2020 in the matter of Praveen Khatri & Ors Vs. GNCTD & Ors., and Contempt Petition No. 289/2022 in the matter of Shweta & Ors vs DSSSB, the E-Dossiers of the candidates having roll No.2280006320, 2280003799, 2280004239, 2280006685, 2280003033 are called, subject to attaining the minimum qualifying marks and correctness of the information furnished by the candidate in his/her application form for the post of Special Educator, post code 15/17.

- 2. The above court case linked candidates are hereby informed to fill the E-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-Dossier module in OARS link in his/her individual account in OARS module.
- 3. The link for uploading of E-Dossier shall be kept open for a period of 15 days w.e.f., 06.07.2022 to 20.07.2022 only for the above court case linked candidates, failing which his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 4. The candidate uploading E-dossier should ensure that he/she fulfils all the eligibility criteria as on the cutoff date, i.e., 15.09.2017. The Shortlisted candidate is also being separately informed through SMS & E-Mail on his/her registered mobile number & E-mail id as additional facility. If, any candidate fails to upload the E-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading E-dossier will be given on whatsoever ground.
- 5. THE LINK FOR UPLOADING OF E-DOSSIER SHALL BE OPENED ONLY FOR THE ABOVE COURT CASE LINKED CANDIDATES W.E.F. 06.07.2022 to 20.07.2022
- 6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
